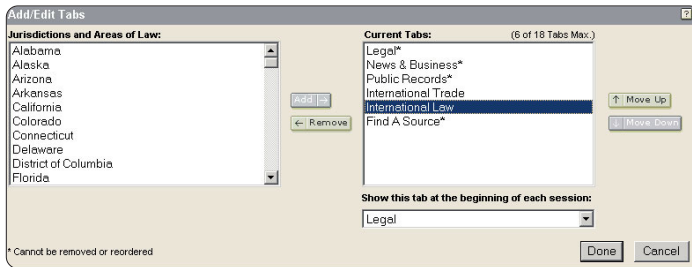

European Union

Full-text decisions of the European Court of Justice and the Court of First Instance are available on the LexisNexis services. To find a specific case when you know the name of the parties, for example, *Rewe-Zentral AG v Bundesmonopolverwaltung für Branntwein*:

PATH: Legal > Legal Excluding US > European Union > CELEX European Union Cases
SEARCH: *name (rewe zentral AND branntwein)*

To find all cases involving a specific party, for example, Greece:

PATH: Legal > Legal Excluding US > European Union > CELEX European Union Cases
SEARCH: *name (greece)*

European Union Law includes Treaties, Legislation, Preparatory Documents, National Provisions Implementing Directives, and Parliamentary Questions as provided by CELEX — the computerized documentation system on EU law, which the EU institutions make available to their officials and the public. Sources include Series L and C of the Official Journal of the European Communities, SEC and COM final documents, etc.

To research EU documents (legislation, preparatory acts, etc.) on a particular subject, for example, labeling and traceability of foodstuffs containing genetically modified organisms:

PATH: Legal > Legal excluding US > European Union > Legislation & Regulations > CELEX EU Database: Combined Files
SEARCH: *title (genet! modif! organ! AND label!)*

Use the FOCUS™ feature to narrow your results to a specific topic, e.g., Commission Regulation No. 1830/2003. Click *FOCUS —Narrow Results* and then enter your FOCUS search. *Title (1830 pre/2 2003)*

To gain an EU perspective of the latest steel tariff controversy with the U.S:

PATH: Legal > Legal Excluding US > European Union > News > EU News
SEARCH: *steel AND united states AND date =2003*

British Commonwealth

If you know which country and court rendered a decision, select a specific source, such as England and Wales Reported and Unreported Cases. If you are uncertain which country or court rendered the decision, or if you are exploring an issue that crosses common law jurisdictions, search one of the combined sources such as Commonwealth and Irish Cases, Combined.

To find Commonwealth cases citing CITES—the Convention on International Trade of Endangered Species:

PATH: Legal > Commonwealth > Case law > **Commonwealth & Irish Cases Combined—Grouped by Country**

SEARCH: *convention PRE/5 endangered species*

To locate English cases discussing trademark infringement of a unique or distinctive mark:
