that somebody else is going to tap into it or pull it from an email.

"We're able to send it to them in that secure platform and not have to be concerned about whether someone's going to hack into it or anything like that. They do world-class security."

"Going back to pre-Time Matters days, when we did the preliminary bills, we'd print out 200, 300, 400 pages of paper and we did that sometimes twice a month. And now it's all within the computer so we don't have to use up the paper."

Mr. Coleman also uses the reporting feature in Billing Matters to help him understand the financial workings of his firm, including helping determine his attorneys' compensation.

"I'm still the only equity lawyer in the firm and the other lawyers' compensation is based on their collected billings," he said. "As they record their time and develop their invoices, I can review the files. I can review the billing summaries. I can review their time. "Billing Matters has a report that generates their collected billings for whatever period of time I want to ask for.
