Campbell** (Johns Hopkins University School of Nursing) was given the August Vollmer Award for outstanding contributions to applied criminology. **Bob Bursik** (University of Missouri, St. Louis) received the Herbert Bloch Award for outstanding contributions to ASC and the professional interests of criminology. **Barry Feld** (University of Minnesota Law School), **D. Wayne Osgood** (Pennsylvania State University), **Richard Rosenfeld** (University of Missouri, St. Louis), and **David Weisburd** (University of Maryland) were named 2005 ASC Fellows. **Gary LaFree** (University of Maryland) is the current president of ASC; **Michael Tonry** (University of Minnesota) will assume the office in November 2006.

## PACE Encourages Four-Year Degree Seeking for Police Officers

The mission of the Police Association for College Education (PACE) is to advance the quality of police agencies and services by encouraging and facilitating a minimum education level of a four-year college degree for officers.

This goal recognizes the high level of professional responsibility of officers, as recommended by six national commissions and the federal courts. The goal is nationwide universal achievement of this mission. "Police officer" is defined as any person empowered by a state or local government to have general police powers.

PACE activities include: recommending to all police agencies that they adopt the four-year degree minimum education standard for all officers, both directly and through their professional organizations; assisting police agencies and organizations in developing plans to implement a four-year college degree requirement for both entering and in-service officers; assisting police agencies in enhancing recruitment procedures to ensure that minority and female representation among officers is both maintained and increased with the four-year college degree requirement; encouraging and

facilitating police agencies to require advanced degrees for senior management positions; assisting police agencies with the recommended standards with any problems encountered in administering such programs; assisting police agencies in maximizing benefits from the higher capabilities of college-degreed officers; assisting college-degreed officers in facilitating improvements in their agencies and their quality of service, including a more collegial, less authoritarian, professional environment; conducting a national public information service to educate the public concerning the importance of college-degreed officers, as well as to respond to press inquiries; collecting, maintaining and disseminating research information concerning the subject of college-degreed officers, including legal opinions; and assisting those who are engaged in research concerning college-degreed officers.

## JSA to Hold June Conference in Berkeley

The Justice Studies Association (JSA) will hold its Eighth Annual Conference at the University of California, Berkeley, June 8-10, 2006. The theme of the conference is "Where Do the Children Play? Considering Future Generations through Peace, and Social and Restorative Justice." Activists, care providers, policymakers, and scholars from all disciplines who have an interest in these areas are invited to submit a proposal before April 1, 2006.

Presentations are welcome on topics dealing with the nature of societies, communities, families, schools, and interpersonal and environmental relationships that have a bearing on the future of our children. Particular attention will be given to reflections on these themes from the perspective of social, economic, political, restorative, and transformative justice.

Suggested topics include: (1) an investigation of a just relationship between the human community and the natural world; (2) the use of peaceful conflict resolution and restorative justice to address issues facing children and families; (3) experiments with forming just communities and their impact on family living arrangements, family work relationships, gender relations, and parenting; (4) reflections on the effects of the criminal justice system on parents, children, and families; and (5) efforts to unmask the violence of daily life from oppressions on children and adults in their living, playing, and working worlds.

A production by Frontline, titled *Sex Slaves*, covers the sex slave market in Turkey and includes astonishing footage of the business as well as considerable interview time with the women/girls. The film follows a man who journeys deep into the world of sex trafficking to try to find his wife and free her from the violent pimp who "owns" her. Along the way, the production team takes a rare

look at the various traffickers, pimps, and middlemen who illegally buy and sell hundreds of thousands of women each year.

## In Memoriam: James J. Fyfe

**James J. Fyfe**, distinguished professor of criminal justice at The Graduate Center and John Jay College, died on November 12, 2005. One of the nation's preeminent police scholars, at the time of his death he was serving as the New York Police Department's deputy commissioner of training.

Fyfe held a B.S. from John Jay College and an M.A. and Ph.D. from SUNY-Albany. He published seven books and more than 100 articles and book chapters, winning several awards for his research and the effects it had on police policy and practice. Fyfe served for 16 years and earned seven citations from the New York City Police Department, retiring in 1979 at the rank of lieutenant. He returned as deputy commissioner in 2002 while on leave from the City University of New York (CUNY), and worked to revamp the training and educational policy of the department.

He also taught at American University, Temple University, and Charles Stuart University (Australia); was a senior fellow of the Police Foundation; and served as a commissioner of the Commission on Accreditation for Law Enforcement Agencies. Fyfe testified as a police practices expert in the United States Senate and Congress and in federal and state courts in the United States and Canada. Among the many notable cases in which he was consulted and/or testified was *Tennessee v. Garner*, *Thurman v. City of Torrington*, and *New Jersey v. Soto* (racial profiling on the New Jersey Turnpike). He also testified against the police officers accused of murder in the Amadou Diallo case as well as the officers who beat Rodney King. He was a commentator on police and criminal justice matters in hundreds of national and local media appearances.

Fyfe's family members include his wife, **Candace McCoy**, professor of criminal justice at The Graduate Center and professor at Rutgers University's School of Criminal Justice, three daughters, and two grandchildren.

## Scholarship Named for Slain John Jay Graduate Student

While criminologists from across the country were convening in Baltimore at this year's American Society of Criminology meeting, they were shocked and saddened by the tragic news that John Jay College graduate student **Imette St. Guillen** was found brutally murdered.

On March 12, 2006, Police Commissioner **Raymond Kelly** announced that authorities would take DNA and other evidence to a grand jury to seek an indictment against **Darryl Littlejohn**, a bouncer at the bar where St. Guillen was last seen alive. Sometime during the next 17 hours, she was raped, strangled, and suffocated.

St. Guillen enrolled in John Jay College in 2004, initially to pursue a master's degree in forensic psychology. In Fall 2005, she changed her principal field of study to criminal justice, and was scheduled to graduate this Spring. St. Guillen was a Dean's List student at John Jay College.

A John Jay College scholarship in St. Guillen's memory has been established by the local chapter of the Alpha Phi Sigma criminal justice national honor society. ## CJR Welcomes Film Reviews

The *Contemporary Justice Review (CJR)* is an interdisciplinary journal for scholars, practitioners, and activists of justice around the globe who seek to explore new models and demonstration projects that have applicability to social systems from the local to the international level. *CJR* welcomes film reviews for publication. Film reviewers should offer critical comments about a film's value for helping readers understand issues of justice in their lives, with justice defined in the sense of people having their needs met and achieving well-being after they have been subject to some form of suffering or harm. To achieve this end, reviewers might find it of value to situate the film reviewed in its cinematic and sociohistorical context.

The length of film reviews should be between 750 and 1,500 words. It is preferred that reviews not contain references but, when necessary, reviewers should consult the *Publication Manual of the American Psychological Association* (Fifth Edition). Other films can be cited in the text of the review simply by referencing title and filmmaker. Reviewers are encouraged to keep quotes to a minimum.

All reviews should be preceded by a full bibliographic citation for the film in this sequence: full title in italics; director; production company and/or distributor; date; running time; language; MPAA (Motion Picture Association of America) rating; and format availability.

Reviews are due within three months after the editor has been contacted about the subject. In general, reviews are published on a first-submitted, first-published basis. The editors of *Contemporary Justice Review* reserve the right to edit for style and grammar and to refuse to run the final review should its contents prove to be inconsistent with the aims and standards of the journal.

## Online Crime Mapping Now Offered to Los Angeles Residents

A new initiative from the Los Angeles Police Department (LAPD) allows Los Angeles residents to track crime patterns throughout the city. The LAPD's interactive crime mapping feature on the department's web site allows users to pinpoint by date and location specific crimes, including robbery, assault, rape, and homicide, up to five miles from a particular address.

The LAPD has traditionally posted weekly and annual crime trends for each of its divisions. With the new mapping feature, residents can see whether a rumored burglary spree is real, parents can survey the block where their teenagers want to go to a party, and

house buyers can see for themselves whether a particular street is "safe." The site (<http://www.lapdonline.org>) also offers an option for residents who want the latest crime news delivered straight to their e-mail inboxes.

Although crime mapping was pioneered by the city of San Diego about 10 years ago, the LAPD's effort, covering more than 470 square miles, may be the most extensive yet.

While the Department states that it is unable to provide routine assistance with academic research matters, at the discretion of the Chief of Police, it will occasionally participate in research projects that are of direct benefit to

### Mountain State University

Mountain State University (Beckley, WV) has expanded its Bachelor of Science degrees in Criminal Justice to include a choice of three concentrations: Homeland Security, Police Science, and Corrections Management. The program is grounded in a liberal arts tradition, and students are required to satisfy 36 hours of general education, 39 hours of criminal justice core courses, and 40 hours of courses in one of the concentrations. The Police Science concentration focuses on both a science and administrative preparation for policing-related issues. Curriculum content includes investigative, patrol techniques, management and administration, terrorism, and forensic science courses and allows an effective cross-study with the (B.S.) Crime Scene Investigation program.

The Corrections Management concentration focuses on relevant issues relating to the management and functioning of correctional institutions in criminal justice. The curriculum focuses on administrative, legal, and functional aspects of jails, prisons, and community corrections programs.

All three of the concentrations represent the growing needs of the criminal justice community in Southern West Virginia and surrounding states. A supporting program is the Books to Badges Program, which allows students the opportunity to complete Associate, Bachelor's, and Master's degrees in Criminal Justice while being actively employed or enrolled in internships or practicum with local criminal justice agencies. Law enforcement and correctional agencies in Southern West Virginia are actively recruiting entry-level professionals. Students may elect to complete several years of full-time study, and while enrolled, may apply for these entry-level positions. ## Grant Availability

### The Harry Frank Guggenheim Foundation

The Harry Frank Guggenheim Foundation sponsors scholarly research on problems of violence, aggression, and dominance. The Foundation welcomes proposals from any of the natural and social sciences and the humanities that promise to increase understanding of the causes, manifestations, and control of violence, aggression, and dominance. Highest priority is given to research that can increase understanding and amelioration of urgent problems of violence, aggression, and dominance in the modern world.

Particular questions that interest the Foundation concern violence, aggression, and dominance in relation to social change, the socialization of children, intergroup conflict, interstate warfare, family relationships, and investigations of the control of aggression and violence. Priority will be given to areas and methodologies not receiving adequate attention and support from other funding sources.

The Foundation awards research grants to individuals for individual projects and does not award grants to institutions for institutional programs. For administrative convenience, a grantee may choose for the foundation to pay grant funds to an institution on behalf of the grantee, rather than to the grantee directly. Applications must clearly specify whether the funds requested will be administered through an institution or will be paid to the grantee directly.

Awards are generally in the range of \$15,000 to \$30,000 a year for periods of one or two years. Applications for larger amounts and longer durations must be very strongly justified. All awards are for one-year terms initially. Further funding of projects tentatively approved for more than one year will require annual applications for continuation and will depend upon evidence of satisfactory progress and an account of expenditures during the previous year. Requests will be considered for salaries, employee benefits, research assistantships, supplies and equipment, field work, essential secretarial and technical help, and other items necessary to the successful completion of a project. The foundation does not supply funds for overhead costs of institutions, travel to professional meetings, self-education, elaborate fixed equipment, or support while completing the requirements for advanced degrees. The foundation will not accept applications for the support of meetings and conferences or travel costs for participants.

Past awards in recent years have been granted to **Richard B. Felson** (Sociology, The Pennsylvania State University) on distinctive characteristics of marital violence; **John Hagedorn** (Criminal Justice, University of Illinois, Chicago) on violence, gangs, and the redivision of space in Chicago; **Bruce A. Jacobs** (Criminology, University of Missouri, St. Louis) on criminal retaliation, a qualitative study of social control beyond the law; and **Shadd Maruna** (Criminology, Northwestern University) on understanding public punitiveness toward offenders.
