had been hesitant to sell new versions of CaseMap to my clients for the past several years because I had some concerns about the price point relative to the functionality enhancements," explains Jacintha ("Jay") Hodgson, a 20year veteran litigation software consultant with the UK-based consulting firm, Hassnet Ltd. "So when I heard that LexisNexis was taking some major strides with the CaseMap 10 version of the software, I was curious and asked to serve as a beta tester. What I saw in the beta really excited me. These new features make me want to sell CaseMap to my clients again!"

Hassnet Ltd. is a distributor of several leading litigation software products to European law firms. One of the products Jay supports is CaseMap fact and issue management software from LexisNexis, which she has installed in approximately 50 law firms over the years. CaseMap helps litigation teams bring together the relevant facts, documents and issues of each case into a central location for improved case assessment.

Last month, LexisNexis announced the introduction of CaseMap 10, a new version of the software that features full-text search capabilities and now allows users to bulk import virtually any

kind of electronic document into the CaseMap database.

Hodgson, like other CaseMap users who beta tested the product prior to release, found five key features most appealing:

1. Revised Interface

Hodgson immediately liked the reworked opening screen for CaseMap, which she found much less crowded and easier to navigate.

2. Improved Search Functionality

"Once I started working with the software, I was immediately impressed by the much-improved search tool in CaseMap 10, which gives users the ability to search across the entire CaseMap case database of spreadsheets and documents," said Hodgson. "This enables us to pinpoint key information and evidence very quickly, which is extremely



valuable to busy litigation professionals."

3. Easier Document Importing

The next thing that struck Hodgson was the new document importing capability in CaseMap 10, which makes it easier to work with key documents — regardless of whether they are PDFs, emails or Word files — by giving them access to everything related to the case in one location.

4. Bulk OCR

"Another really great enhancement in CaseMap 10 is that the software now supports bulk OCR of documents," she noted. "One of the great benefits to this for users is that the text contained within document images is now searchable, so we can quickly locate key information and do faster case analysis."

Once I started working with the software, I was immediately impressed by the much-improved search tool in CaseMap 10. It also integrates with Microsoft Office and SharePoint.

5. Microsoft Integrations

CaseMap 10 also delivers integration with Microsoft Word, Microsoft Outlook and Microsoft SharePoint. According to Hodgson, this will allow users to seamlessly send work product and case data to CaseMap from within a Microsoft application so they can centralize key case documents and facts in CaseMap without having to enter the information twice or perhaps cut and paste sections of text. Users can also install a SharePoint "web part" to view real-time CaseMap data on a case team or matter, as well as grant access to the page for clients and co-counsel.

"Most of all, however, I was very impressed with the stability of CaseMap 10, which has always been a real hallmark about the development of this software," she said. "I'm someone who takes a critical look at the upgrade features with each new version release of a software product and asks, 'Would I pay the upgrade money just to buy those features?' Often, the answer is No," says Hodgson. "But with Case-Map 10, I was lucky to be part of the beta testing group and I can state clearly that this is a very powerful upgrade every law firm will want to make sure they acquire. Go look at the webinars if you haven't already done so and you'll probably get excited."
