#### Get Contact Information from Martindale-Hubbell®

Through the Martindale-Hubbell forms on our Law School Career Center you can find contact information for attorneys and firms by location, practice area, law school or other search terms.

#### Finding Law School Alumni

- Go to [www.lexisnexis.com/lawschool](http://www.lexisnexis.com/lawschool) and sign on
  - Click the **Career Center** tab at the top of the page
  - Click **Search Martindale-Hubbell** on the left
  - Click the **Location/Area of Practice** tab
  - Select **Lawyers Only** in the Look For drop-down menu
  - Select **Energy** in the Major Practice Area field
  - Enter **Yale** in the Law School field
  - Click the **Search** button
- 📎 When entering your school's name you must account for the different derivations in spelling (e.g., University of California Los Angeles or UCLA or U.C.L.A.).

#### Finding Attorneys by Location and Practice Area

- Click **Back** to return to the Martindale-Hubbell search form
  - Click the **Location/Area of Practice** tab
  - Select **Lawyers Only** in the Look For drop-down menu
  - Select **Civil Rights** in the Major Practice Area field
  - Enter **Washington** in the City field
  - Click the **Search** button
- 📎 If city is too narrow a restriction you can use the States/Provinces menu.

#### Finding Law Firms by Size, Location and Practice Area

- Click **Back** to return to the Martindale-Hubbell search form
  - Click the **Location/Area of Practice** tab
  - Select **Law Firms Only** in the Look For drop-down menu
  - Select **Commercial Law** in the Major Practice Area field
  - Select **50+** from the Firm Size drop-down menu
  - Enter **Chicago** in the City field
  - Click the **Search** button
- 📎 Notice the changes to the search form when selecting Law Firms Only (e.g., there is no Law School field).

#### Finding Law Firms with Law School Alumni

- Click **Back** to return to the Martindale-Hubbell search form
  - Click the **Location/Area of Practice** tab
  - Select **Law Firms Only** in the Look For drop-down menu
  - Select **Bankruptcy** in the Major Practice Area field
  - Select **50+** from the Firm Size drop-down menu
  - Enter **Duke /3 School /3 Law** in the Additional Terms field
  - Click the **Search** button
- 📎 Duke /3 School /3 Law finds any attorneys in the related firms listing Duke University School of Law as their law school.

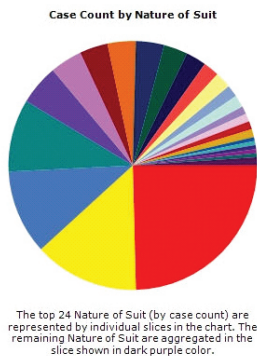

## Interview Preparation Resources

### Finding Strategic Profiles for Attorneys and Firms:

- Click the **Research Now** button at the top left of the page
  - Click the **Search** tab at the top of the LexisNexis Research System
  - Scroll down on the right and click **Court Records from CourtLink®**
  - Click **Litigant, Attorney, & Judge Strategic Profiles** to access CourtLink
  - Click the **Attorney/Law Firm** tab
  - Use the drop-down menu under **Select Court** to choose your jurisdiction
  - Type **FIRST NAME LAST NAME** in the field under Name of Attorney.
  - Select your **Date Range**
  - Click the red **Create Profile** button
- ☞ You can control the presentation of your profile through the **Chart Type** and **Report Selections** options at the bottom of the form.

### Top 5 Interview Preparation Research Tips:

#### Finding Cases Where an Attorney or a Firm is the Counsel of Record

- Go to [www.lexisnexis.com/lawschool](http://www.lexisnexis.com/lawschool) and sign on
  - Click the **Research Now** button at the top left
  - Select **Federal & State Cases, Combined** as your source
  - Select **COUNSEL** from the Select a Source drop-down menu
  - Enter **Marisol /3 Sanchez** and click the **Add** button
  - Click the red **Search** button
- ☞ You can search the COUNSEL segment with a Firm's Name rather than an attorney's name to retrieve cases involving a specific firm. You can also add other search terms to find cases involving firms or attorneys for a specific legal issue.

### Finding Briefs and Motions filed by Attorney or Firm

- Click the **Search** tab at the top of the page
  - Select **All Federal and State Briefs and Motions, Combined** as your source
  - Select **COUNSEL** from the Select a Source drop-down menu
  - Enter **Bose McKinney** and click the **Add** button
  - Click the red **Search** button
- ☞ You must search U.S. Supreme Court Briefs separately through its own source.

### Finding Law Review Articles Authored by Individuals

- Click the **Search** tab at the top of the page
  - Click the blue **Law Reviews & Journals** link.
  - Select **US & Canadian Law Reviews, Combined** as your source
  - Select **AUTHOR** from the Select a Source drop-down menu
  - Enter **Manning /3 Warren** and click the **Add** button
  - Click the red **Search** button
- ☞ Searching the Author segment retrieves articles written by an individual as well as articles acknowledging an individual.

### Finding Martindale-Hubbell Legal Articles Authored by Firm

- Click the **Search** tab at the top of the page
  - Click the blue **Reference** link
  - Click the blue **Martindale-Hubbell – Legal Articles** link
  - Select **Martindale-Hubbell Legal Articles** as your source
  - Select **BYLINE** from the Select a Source drop-down menu
  - Enter **Squire Sanders** and click the **Add** button
  - Click the red **Search** button
- ☞ Martindale-Hubbell Legal Articles offer attorney insights into decisional law, commentary on new statutes and regulations and other professional developments.

### Finding News Articles about an Attorney or a Firm

- Click the **Search** tab at the top of the page
  - Click the **News & Business** tab
  - Select **News, Most Recent Two Years** as your source
  - Enter the name of the individual or firm
  - Click the red **Search** button
- ☞ There are news sources organized by market and industry as well (e.g., Legal News Publications).
