# **SCOPE AND CONTENT NOTE**

This edition includes files on the problem of racial segregation and discrimination in public facilities and within private organizations. The records cover the period between 1940 and 1955—the decade and a half leading up to the 1954 U.S. Supreme Court ruling in *Brown v. Board of Education*, which declared racial segregationist practices unconstitutional. The files selected for the microfilm are from the General Office File of the NAACP collection. This is a companion to Part 15, Series A of *Papers of the NAACP*, which reproduces selections covering segregation and discrimination from the Legal Department File during the same period.

Files on segregation and discrimination in other contexts have been made available as separate editions of UPA's microfilm collection, *Papers of the NAACP*. On public education, see *Part 3, The Campaign for Educational Equality*; on voter discrimination and disenfranchisement, *Part 4, The Voting Rights Campaign*; on segregation and discrimination in residential housing, *Part 5, The Campaign against Residential Segregation*; on discrimination in the criminal justice system, *Part 8, Discrimination in the Criminal Justice System*; on segregation and discrimination in the Armed Forces, *Part 9, Discrimination in the U.S. Armed Forces*; on segregation and discrimination in the workplace, *Part 10, Peonage, Labor and the New Deal*; and *Part 13, The NAACP and Labor, 1940–1955*. Records on discrimination and segregation in public facilities for the period before 1940 can be found in *Part 11, Special Subject Files, 1912–1939* and in *Part 12, Selected Branch Files, 1913–1939*.

# Series B

The bulk of the files in this edition predate the 1954 *Brown* decision. Thus the records on this microfilm provide valuable insights into how the NAACP worked to oppose segregation before there were federal grounds to attack the practice. As the files in the companion edition, *Part 15, Series A, Segregation and Discrimination, Complaints and Responses, 1940–1955: Legal Department Files* show, there were few opportunities to file court cases at the state level except in rare cases where the states had meaningful civil rights laws. Therefore, the NAACP focused its energies on political action and propaganda to pressure city councils, state legislatures, and the United States Congress to pass legislation that would make instances of racial segregation actionable in a court of law. Much of the present edition documents the political campaigns the NAACP waged to enact civil rights laws in the states and at the federal government level

between 1940 and 1955. The files demonstrate that these political campaigns were of uneven effectiveness, but that they succeeded in forging important networks of pressure groups among the NAACP and liberal organizations, including labor unions. The public relations efforts of the national office and of branch NAACPs are particularly well documented.

Another aspect of segregation and discrimination with which the NAACP contended was that within private organizations. In some cases, private associations discriminated in accepting memberships (as in the case of the American Bar Association); in other cases, private organizations practiced discrimination in the course of their programs (such as the segregated blood banks maintained by the American Red Cross). Before the *Brown* decision in 1954, the NAACP was left with few avenues of litigation against these practices. As the files in this edition show, however, the association responded in a variety of ways to the practices of private associations, ranging from diplomatic protests to denunciatory publicity campaigns.

One area of private action that is especially well covered in this edition is the practice of using derogatory stereotypes to depict African-Americans in advertisements, radio, television, the motion picture industry, and other organs of American popular culture. A lengthy series in this edition under the heading "Publicity Protests" documents the association's responses to this problem. The series also sheds important light on the problem of racism in popular American culture between 1940 and 1955.

Following are brief summaries of the major file series in the order in which they appear on the microfilm.

American Red Cross. This series covers one of the private organizations that the NAACP tried to influence toward ending racially discriminatory policies. The Red Cross maintained segregated blood banks during World War II and in the 1940s, and the NAACP fought to persuade the organization to abandon the practice. The NAACP also protested racial discrimination by military service clubs sanctioned by the Red Cross and investigated allegations of racial discrimination in Red Cross disaster relief. (See also the Chinese Blood Bank series described on p. ix.)

Marian Anderson. These files document several benefit concerts given by Marian Anderson for the NAACP. They also document the evolution of the singer's protest against segregationist seating practices at her concerts. The series also contains a survey of black performing artists on the issue of boycotting segregated audiences. There is also a small amount of information on Marian Anderson's famous Lincoln Memorial concert on Easter Sunday of 1939.

*Bills.* There are three subjects covered by this series: NAACP testimony before Congress on proposed federal civil rights legislation in 1949; state legislative bills affecting civil rights, either in the form of eliminating segregation or promoting it; and bills to eliminate racial segregation in the District of Columbia.

Buses for Colored Orchestras. This file concerns the World War II era segregation of African-American musicians traveling through the South to entertain American troops at military facilities.

Chinese Blood Bank. This file concerns the NAACP support for the nonsegregationist policies of the effort to collect blood for shipment to wartime China.

Civil Rights. There are several subjects covered within this file series. The file on "Civil Rights Conference" documents planning for the Civil Rights Mobilization lobby of the early 1950s. The files on the "Joint Committee on Civil Rights" and "Meetings of Organizations" described a few paragraphs below complement the material in this folder. (The Civil Rights Mobilization movement, in which the NAACP spearheaded a coalition of liberal, labor, and civil rights organizations to press for a federal civil rights act, is exhaustively documented in *Papers of the NAACP*, Part 13: The NAACP and Labor, 1940–1955.)

"District of Columbia" files in the Civil Rights series cover segregation and discrimination in the District and initiatives for civil rights legislation governing the District, including "home rule" proposals.

The General files of the Civil Rights series include complaints, reports, and correspondence. The complaints reveal the resentment African-Americans harbored over incidents of discrimination or segregation at hotels, restaurants, theaters, hospitals, recreational facilities, and in public transportation, employment, housing, the criminal justice system, and other contexts. Many of the incidents occur within the context of the migration of blacks into urban industrial centers during the 1940s. The General files also include correspondence between the NAACP and numerous other organizations that opposed segregationist policies during the 1940s and early 1950s, including the Americans for Democratic Action, the American Civil Liberties Union, the Association of Colored Graduate Nurses, American Jewish Congress, the Japanese American Citizens' League, and the Congress of Industrial Organizations. In addition, correspondence with the International Labor Defense and the Civil Rights Congress touches on the issue of Communist involvement in the civil rights movement. There is also material on efforts of anti-Communists such as members of the Dies Committee in Congress and officials in the federal Loyalty-Security program to use the Communist issue to retard the cause of civil rights.

A file under Civil Rights Handbook contains a manual written by the NAACP national office for distribution to local NAACP branches for guidance in protesting segregation. The handbook gives detailed advice on handling a wide range of cases before there were constitutional grounds to use in attacking segregation.

The "Joint Committee on Civil Rights" file and the "Meetings of Organizations in Washington, D.C." file both cover the NAACP's leadership in forming a political lobby to press for federal civil rights legislation in the late 1940s. These files complement the "Civil Rights Conference" file described above.

The "States" file contains material on existing laws and civil rights bills in state legislatures all around the United States between 1951 and 1955. The file also documents civil rights programs in states and NAACP branch activities.

The "Bills" files include careful coverage of a municipal civil rights bill in Albuquerque, New Mexico, as well as information on a state civil rights law in New Mexico. The "Bills—Federal" series includes reports on the progress of numerous other state civil rights bills during the 1940s. That file focuses, however, on efforts to have Congress take up civil rights legislation in the late 1940s. The "Bills—Congressmen" file documents the arguments of opponents of federal civil rights legislation.

The remainder of the files under the heading Civil Rights Bills were inadvertantly omitted from this edition. The entire Civil Rights Bill series has been reproduced in *Papers of the NAACP*, *Part 18: Special Subjects*, 1940–1955, Series A: General Office Files. Intermarriage. A very short file on legal discriminations against interracial marriages suggests that the topic was not one that the NAACP chose as a priority in the 1940s.

Leagues. The Leagues series of the NAACP collection is an extensive arrangement of files on other organizations with which the NAACP corresponded. The entire series was surveyed by the editors, and files were selected that document the NAACP efforts either to work with organizations combatting segregation or to persuade organizations to desist from segregationist policies.

The "American Heritage Foundation" files from the Leagues series illustrates a case where the NAACP sought to ensure equal access by African-Americans to the Freedom Train, a traveling exhibit of documents and artifacts celebrating American history. The association used the occasion to mount a public relations campaign ridiculing segregationist policies imposed on the exhibit by the laws in southern states, particularly in Alabama.

The "Chicago Commission on Human Relations" monitors the work of an urban commission studying the impact of racial discrimination in one of the major American urban areas.

The "Daughters of the American Revolution" series concerns NAACP efforts to persuade the DAR to eliminate discrimination against black performers at Constitution Hall in the District of Columbia. The "Girl Scouts of America" file documents efforts by the GSA to encourage racial integration within the organization. The "National Association of Intergroup Relations" files cover the NAACP's cooperation with an organization working to promote racial integration in American society.

The "National Committee on Segregation in the Nation's Capital" files contain extensive reports on the impact of racial discrimination in the District of Columbia during the 1940s and 1950s.

"N" in Negro and Negress. These two files document the NAACP's vigilance against derogatory references to African-Americans in popular usage.

Negroes in Crime Stories. This file documents NAACP protests against the tendency of the new media—particularly the New York City press—to sensationalize crime stories involving African-American suspects.

*Nurses.* This series documents the role of the Association of Colored Graduate Nurses in combatting discriminatory practices in hospital hiring and segregation in hospital admission.

Publicity Protests. This large series covers the NAACP's efforts to influence the depiction of African-Americans in popular media, including the radio, television, and motion pictures. The first subseries are the "Amos 'n Andy" files, which cover the NAACP-led protest against the popular radio and television show. The "Broadcasts" series covers many more incidents of derogatory references to African-Americans in a variety of radio and television programs. The "General" files are the largest subseries in the group, and they cover derogatory representations of blacks in various print media, including magazine advertisements, promotional brochures, product wrappings, posters, and billboards, as well as in broadcasts, newspapers, motion pictures, and song lyrics. They also concern the segregation of audiences in the performing arts. Separate files focus on the "Little Black Sambo" publication, actress "Hattie McDaniels," and "Minstrel Shows."

Jackie Robinson and Sports. These two files cover discrimination in professional sports. The Robinson file concerns baseball and documents Jackie Robinson's advocacy of integration. The Sports file covers professional boxing, collegiate athletics, and municipal segregation laws affecting sporting facilities.

Sydenham Hospital. This series of files documents efforts to integrate a major hospital in the Harlem section of New York City. The General file also includes material on integration of hospitals in Cleveland, Ohio.

Uncle Tom's Cabin. This file focuses on attempts by NAACP branches—some in cooperation with the Communist Party, USA—to protest stage performances of "Uncle Tom's Cabin" in the late 1940s. These attempts put NAACP branches at odds with a usual NAACP ally, the American Civil Liberties Union. The NAACP national office eventually pressured the local branches to desist from picketing the productions.

United Seamen's Service. This series of files documents efforts to integrate facilities for the merchant marines in the southern states and abroad.

Young Men's Christian Association and Young Women's Christian Association.

These file document efforts of these two voluntary associations to encourage racial integration among their affiliates.

# **NOTE ON SOURCES**

All documents reproduced for this edition are held by the Manuscripts Division of the Library of Congress, Washington, D.C. The original NAACP collection at the Library of Congress is subdivided into four accession groups: Group I, 1909–1939; Group II, 1940–1955; Group III, 1956–1965; and Group IV, 1966–1975. The records making up *Part 15, Series B* of this publication are drawn exclusively from Group II, Series A, General Office File.

This edition was compiled after a thorough survey by Professors August Meier and John H. Bracey, Jr. of the second accession of the NAACP collection of the Library of Congress. Every file selected for inclusion has been microfilmed in its entirety.
