

NOTE ON SOURCES

This publication reproduces the complete collection of James Henry Hammond Papers from the South Caroliniana Library, University of South Carolina, through the year 1865. Portions of the collection dating beyond 1865—relating entirely to Hammond's descendants—were not microfilmed and are on deposit at the South Caroliniana Library. Reels 13–15 reproduce Hammond Plantation Journals from the Library of Congress. The voluminous correspondence files of James Henry Hammond at the Library of Congress are not a part of this publication. That collection—predominantly but not exclusively political in nature—is available on microfilm from the Library of Congress.

EDITORIAL NOTE

The map of the state of South Carolina used on this microfilm is that of Anthony Finley, 1841. Maps of the individual districts are from Robert Mills, *Atlas of South Carolina*, 1825.

Reel 1

James Henry Hammond Papers, 1785–1865, Barnwell and Edgefield Districts, South Carolina

James Henry Hammond (1807-1864) was a leading statesman and planter of ante-bellum South Carolina, serving in the U.S. House of Representatives and the U.S. Senate and as governor of South Carolina. Hammond was a leading proponent of scientific agriculture in the South. These extensive papers provide information on planting cotton and other crops, including vegetables, grapes, and fruit trees, education, family life, the practice of law, politics, and slave management. The collection also includes miscellaneous business papers; papers of Hammond's brother Marcus Claudius Marcellus Hammond (1814-1876); and correspondence and other papers of Hammond's sons, Harry (1832-1916) and Edward Spann (1834-1922). Among the volumes are selections of his original poetry, student notes while attending South Carolina College, a medical diary of his European tour, autobiographical thoughts and recollections, scrapbooks of published poetry and political letters; a letterbook (1831-1833) regarding politics and the organization of his plantation; a two-volume plantation journal (1831-1887); two stud books (1830-1840) with records relating to his horses and their winnings; volumes of crop statistics and orchard records; plantation, personal, and travel account books; and lumber and canal records. The 1860 census listed 21 slaves living at Hammond's home plantation, Redcliffe, and another 294 living at Silver Bluff plantation. Silver Bluff plantation records were kept by son Paul F. This collection from the papers of James Henry Hammond (1807–1864) contains four personal diaries dating from 1836 to 1855, a common place book of 1829, miscellaneous notes of 1850, plantation books dating from 1832 to 1858, a slave list of 1846, an account book of 1849–1857, and scrapbooks of 1857 and 1858. The plantation books detail crops, livestock, land clearings, crop rotations and experiments, proceeds of crops, contracts with overseers, and the rules of Silver Bluff plantation. Lists of slaves and the number of hands on his plantations are also detailed. Scrapbooks include agricultural publications as well as political notices. The Andrew McLean Letterbook, 1774–1780, contains letters addressed to Clark and Milligan, Merchants, London, relating Andrew McLean's business dealings in the fur trade with the Creeks and Cherokees of East Florida. The no date volume of Hammond Township Districts contains alphabetical lists of whites and Negroes in that township of South Carolina.

Samuel Porcher Gaillard (1811–1880) Plantation Journals, 1835–1871, Sumter District, South Carolina

Samuel Porcher Gaillard, of Orange Grove plantation, owned 122 slaves in 1860. Principal crops were cotton, corn, peas, and potatoes; other notations concern ground nuts, livestock, sorghum, and yams. The seven volumes document life on Gaillard's plantation, including tasks assigned, methods of cultivation, productivity, and the weather. The journal also notes visits to the plantation by physicians, ministers, friends, and relatives. The first few pages of volume 5 are a draft of a historical sketch of French Huguenots in South Carolina, 1640–1690.

John Forsythe Talbert (1825–1890) Plantation Journals, 1838–1868, Edgefield District, South Carolina

The six volumes include a plantation book (1838) listing slave births and deaths, with some family groupings; a plantation time book (1847); and a plantation book (1844–1849 and 1854–1868) containing a record of slave births beginning in 1854, a record of produce and livestock sold, and accounts with freedmen. The taxable produce of this plantation for 1863 included 3,600 pounds of cotton, 19,040 pounds of hay and fodder, 1,200 bushels of corn, and 630 bushels of oats. In 1863 Talbert owned thirty-six slaves. He had as many as forty-five in 1854 and owned thirty-three in 1865.

Caleb Coker of Camp Marion plantation owned 113 slaves in 1860. This daybook was apparently kept by overseer A.A. Chapman, who

supervised forty-five hands. Coker's home plantation was Camp Marion, near Society Hill. The volume includes detailed information on such tasks as the spreading of guano and manure and other daily agricultural duties. There is also detailed statistical data on cotton and corn production

James D. Trezevant Plantation Diary and Records, 1845–1858, Orangeburg District, South Carolina

These two volumes relate to a river plantation known as Hopedale between September 29, 1845, and 1858. The earliest entries apparently chronicle the initial development of the plantation, as Trezevant records the construction of buildings, the arrival of supplies from Columbia, and the hiring of mules and six slaves from a neighbor. Principal crops were corn, cotton, and wheat. Trezevant also raised cattle, hogs, sheep, mules, and horses.

These six volumes contain slave records for rice plantations owned by various members of the Glover family. The plantations include Bull Swamp, Eutaw, Mt. Ouzts was an overseer on several plantations, primarily those of a Mrs. Lowrey. The records detail corn and cotton cultivation with annual summaries of production. By 1871 Ouzts was able to purchase 200 acres of land from R.M. Bledsoe while continuing to manage Mrs. Lowrey's properties. Interspersed with the plantation records are accounts of attendance at religious meetings and other social activities, including visits to fairs.

A native of France, Natalie DeLage Sumter married Thomas Sumter, Jr., around 1802. Her diary is a record of the last year of her life and includes the titles of books that she read, daily entries of prayers, illnesses, and visits by prominent South Carolinians. She also notes details of plantation management, including an instance of a wagoner who was discharged for working slaves in the heat of the day.

Two hundred thirteen loose manuscripts and one volume are reproduced in this publication. The bound volume, 1858, kept by Thomas Coulter Means (1821–1859) records cotton and corn production for that year. In 1859 Mrs. Means was taxed for forty-six slaves. The collection includes records for blankets distributed and trade with slaves for produce. The correspondence with relatives in western territories often concerns deaths of family members and reflects the strong religious feelings of this family. Thomas Family Diaries and Papers, 1702–1706, 1819–1887, St. John's Parish, Berkeley, and Fairfield District, South Carolina

The progenitor of the Thomas family in South Carolina was the Rev. Samuel Thomas, who came to the colony in 1702 as a missionary of the Society for the Propagation of the Gospel. The bulk of the papers in this publication relate to Dr. John Peyre Thomas (1796–1859) and the Rev. Edward Thomas (1800–1840). The private journal and sermons of the Rev. Thomas, who served Episcopal churches in St. John's Parish and Greenville and on Edisto Island, record births, deaths, marriages, funerals, and services held for Negroes; 300 loose manuscript sermons are not included in this publication. Dr. John Peyre Thomas' "Diary of Weather & Occurences" chronicles plantation life and social events from 1828 to 1857. Civil War materials include letters from army camps as distant as Mississippi. Plantations represented in the collection include Betaw, Park Grove, Buck Pond, Valley Grove, and Mount Hope.

James Ritchie Sparkman (1815–1897) Papers, 1822–1865, Georgetown District, South Carolina

Sparkman, a physician and planter of Dirleton plantation, held 166 slaves in the census of 1860. The volumes include an account book, 1827–1845, containing records of the rice mill at Sextus T. Gaillard's

Campfield plantation, 1833-1845, an unidentified factor's records of cotton and rice sales at Charleston, 1827-1832; a memorandum book, 1845-1864, containing slave records, 1845, giving births, deaths, purchases, and familial relationships, and information regarding rice crops at Birdfield; a memorandum book, 1845-1848, for Birdfield containing crop records, particularly for the preparation of rice fields, inventories, tax returns, slave tasks, and medical and business accounts; a memorandum book, 1846–1859, containing inventories and appraisals of the estates of many Georgetown planters; a memorandum book. 1850–1857, containing records of Birdfield plantation, including slaves. rice crops, provisions, medical accounts, and a recapitulation of taxes. 1845-1855; a memorandum book, 1853-1859, containing records of Dirleton, formerly Richfield, plantation, a record of slave births and deaths and clothing and blankets distributed, an inventory of tools and stock, lumber purchases, and crops, together with a broadside advertising the court sale of Richfield plantation and "A Gang of about 111 Negroes . . . To be sold in Families": a memorandum book, 1857–1859. of Birdfield and Dirleton plantations, including rice and other crops. slave birth and death records, and an inventory of tools and stock. agreements with overseers, and records of All Saints Agricultural Society; and a memorandum book, 1859-1861, containing records of Dirleton and Northampton plantations, including slaves, crops, overseers. and stock, together with expenses for a new house begun in 1860. John Stapleton Papers, 1790–1839, Beaufort District, South Carolina

Stapleton, an attorney in England, managed Frogmore plantation on St. Helena Island and Charleston properties, both in the estate of Mrs. Hannah Bull. The estate was administered by Mrs. Catherine Stapleton.

In 1813 there were 122 slaves, 127 head of cattle, 70 hogs, and 50 sheep on the plantation. Letters to Stapleton contain annual accounts of the plantation and slave lists. Lists of 1816 and 1818 are noteworthy as they include dates of birth and family groupings and a record of male and female slaves who had spouses on other plantations. Other correspondence with factors notes crop yields, estate problems, and economic difficulties during the panics of 1819 and 1837.

Thomas Cassells Law (1811–1888) Papers, 1810–1865, Darlington District, South Carolina

Law was a planter who was interested in promoting scientific agriculture and was an active member of the Darlington Agricultural Society. In 1850 he held 33 slaves, 400 acres of improved land, and 640 acres of woodland. The records include slave lists, work routines of slaves, and accounts of trade with slaves. Agricultural society reports, including "Report on the Management of Slaves..." can be found among the papers between 1852 and 1858. The collection also includes papers pertaining to Richland School and Franklin College [The University of Georgia], 1830–1835, as well as later papers on free schools in 1856, and Civil War correspondence, 1864–1865, primarily of Law's son Hugh Lid 2 Law (1847–1918).

John McPherson DeSaussure (1807–1883) Papers, 1816–1876, Kershaw District, South Carolina

DeSaussure, an attorney in Camden, South Carolina, also planted in Kershaw District. In 1860 he listed 301 slaves and 4,030 acres of improved land and 4,921 acres of unimproved land. He kept meticulous records of cotton sold by Charleston factors. The collection includes lists, 1835–1855, of slaves for tax purposes, tax returns, receipts for payments made by DeSaussure as administrator of the estate of R.L. Champion, labor contracts and division of crops between DeSaussure and his tenants and between Mary R. DeSaussure and her tenants, with lists of tenants and their shares, and a plantation account book, 1849–1861. His overseer, D.M. Young, stated in 1854 that there were 1,030 acres in cotton, 743 acres in corn, and 220 acres in oats. At the end of reel 8, there is a summary of annual rainfall and the weather in general, 1858–1881.

Lewis Malone Ayer Papers, 1771–1865, Barnwell District, South Carolina

The 1.567 manuscripts in this collection document the economic and political activities of Lewis Malone Ayer (1769-1863), who served with Francis Marion in the Revolutionary War, and of Lewis Malone Ayer, Jr. (1821-1895), who served in the Confederate Congress. Correspondence with factors, merchants, and other planters shows the growth. especially during the first three decades of the nineteenth century, of the elder Aver's plantation holdings which included cotton and timberlands. The economic effects of the embargo and tariff policies of the early nineteenth century are noted in this collection. At the time of the elder Aver's death in 1863, his estate encompassed nearly 8,000 acres of land and 158 slaves. A slave list showing familial relationships is included among his estate papers. Most of the correspondence of Lewis Malone Ayer, Jr., concerns his service in the Confederate Congress. Correspondents include Alfred Proctor Aldrich, Tarleton Brown. Charleston factor Mordecai Cohen, Richard Creech, James H. Hammond, D.H. Jacques, Darling Peeples, and Robert Barnwell Rhett, "A Calendar of the Lewis Malone Ayer Papers, 1768-1870," prepared by Allen H. Stokes, has been filmed, on frames 0049-0127, in the Introductory Material of this collection.

Read-Lance Family Papers, 1677–1865, Georgetown District, South Carolina

Many of the papers in this collection represent the activities of the Rev. Maurice Harvey Lance (1793-1870) and include land papers, bonds, mortgages, indentures, records of the sale and purchase of slaves, tax receipts, accounts for plantation supplies, blacksmiths' bills, receipts for contributions and dues paid to the Winyah Indigo Society. papers regarding the settlement of estates, and other papers from Georgetown District. Among the papers of John Harleston Read II (1815-1866) of Belle Rive plantation on the Pee Dee River, are legal notes, an article on "Rice Culture," and crop statistics noting annual yields and mills used. A plantation journal, 1850-1858, contains notes on weather, descriptions of rice and corn cultivation, and manuring methods. Lists of slaves in a bound volume and among the loose papers show family groupings, birth dates, occupations, and distributions of clothing. The Rev. Maurice Harvey Lance paid taxes on 149 slaves in 1859, and his plantation. Wedgefield, was listed as containing 154 slaves in the 1860 census.

Heyward Family Papers, 1714–1866, Colleton District and Charleston, South Carolina

The bulk of the papers in this collection relate to Charles Heyward (1802–1866), of Rose Hill plantation on the Combahee River in Colleton District, and other plantations owned by Heyward in the same district. Two journals, 1835-1855 and 1856-1862, kept by Charles Heyward while in residence in Charleston, contain data on weather and information on the health of the city. Plantation books provide information on rice and corn cultivation for Rose Hill, Amsterdam, and Lewisburg plantations. The volumes also document plantation expenses, clothing allocations, rail travel between Charleston and the Heyward plantations in Colleton District, and construction and operation of a steam thrashing mill. Correspondence of overseers and factors shed light on various aspects of plantation management. Charles Heyward appears in the 1860 census as owning 471 slaves in St. Bartholomew's Parish, Colleton District. Slave lists of Edward Barnwell Heyward (1826-1871) in 1863 show ages and family relationships. Labor contracts between the Heywards and various freedmen in 1865 list occupations, as does an 1866 list.

John Ewing Colhoun (c. 1750–1802) Papers, 1763–1854, Pendleton District, South Carolina

John Ewing Colhoun was a lawyer, planter, state representative, and United States Senator. This collection of 416 manuscripts details his law practice and the operation of his plantations. Crops mentioned in the correspondence include indigo, corn, and rice. Letters during the 1780s discuss currency shortages during those years. Correspondents include Robert Anderson, Floride Colhoun, John Couturier, H.W. DeSaussure, John Lewis Gervais, and Arthur Simkins. Among the notable documents in the collection are a pass for an Indian hunter, "the Bird," in Colhoun's employ during 1795, accounts of runaway Negroes stealing hogs, and a series of trials in 1798 of slaves for poisoning whites and other slaves. Other papers relate to his term in the U.S. Senate, 1801-1802. A letter from Benjamin Henry Latrobe in 1802 relates the architect's views of amateurism in building design. The second series of Letter-Size Papers are those of John Ewing Colhoun. Jr. (b. 1791). These papers consist of family correspondence, numbering 43 manuscripts, and include letters to his brother James Edward Calhoun (Colhoun) concerning plantation management and operations and correspondence of son William Ransom Colhoun while attending West Point Military Academy.

Miller-Furman-Dabbs Family Papers, 1751–1865, Sumter District, South Carolina; also Alabama, Georgia, Florida, Mississippi, and Tennessee

John Blount Miller (1782–1851) was the patriarch of these families and is the principal correspondent in the collection. He was Commissioner in Equity for Sumter District over a forty-year period and was active in legal affairs. He was also a planter whose estate, probated in 1851, contained thirty-three slaves and substantial lands. Letters addressed to him and other family members, chiefly from former residents of Sumter District who migrated to other southern states, convey descriptions of life, economic matters, and personal concerns. Hammond, Bryan, and Cumming Family Papers, 1787-1865, Edgefield and Barnwell Districts, South Carolina; also Georgia

This collection pertains to two Georgia families and a South Carolina family. The Bryan family resided in Mt. Zion, Georgia. A Bryan daughter married Henry Harford Cumming, son of a prominent family and later mayor of Augusta, Georgia. Their daughter Emily Cumming married James Henry Hammond's son Harry in 1859. The papers of the Bryan and Cumming families contain extensive family correspondence relating to courtship, marriage, and extended family relations. Correspondence of James Henry Hammond and his son Harry deals with religion, philosophy, politics, education, and agriculture. Correspondence concerning European tours in 1819-1820 and in the mid-1850s document the attitudes of southerners abroad. Harry Hammond's correspondence during the 1850s sheds light upon his academic career at South Carolina College and medical school and later as a faculty member at the University of Georgia. Other papers in the collection relate to army life in the West during the 1850s and the Civil War. Hampton Family Papers, 1777–1858, Richland District, South Carolina; also Louisiana and Mississippi

Wade Hampton I (c. 1751–1835), Wade Hampton II (1791–1858), and Wade Hampton III (1818–1902) were involved in sugar planting in Louisiana and cotton planting in Mississippi and South Carolina. The materials in this collection are primarily business papers detailing crops, marketing, and general plantation expenses, including medical ac-

counts for the treatment of slaves. There is some family correspondence. The material in this collection, especially post-1838, should be used with Charles E. Michael Gramling Plantation Journal and Account Book, 1839–1858, Orangeburg District, South Carolina

This volume details the day-to-day operation of a small cotton plantation. In addition to cotton, Gramling raised corn, peas, potatoes, and livestock. There are also accounts of cotton grown by his slaves for their own use. Fourteen individuals are listed in 1857.

Franklin Harper Elmore Papers, 1818–1877, Spartanburg and York Districts, South Carolina

Franklin Harper Elmore (1799-1850) attended South Carolina College; studied law in Columbia; was admitted to the bar in 1821; acted as solicitor of the Southern Circuit from 1822 to 1836; was elected U.S. Senator in 1836; was elected president of the State Bank in 1839; and shortly before his death was appointed to fill the unexpired term of John C. Calhoun in the U.S. Senate. The earliest documents in this collection relate to his activities as a student at South Carolina College. After this period the bulk of the manuscripts fall into two categories: family correspondence and iron manufacture. Elmore was actively involved in the operations of the Nesbitt Manufacturing Company and the King's Mountain Iron Works, both of which employed slave labor. Papers in 1847 relate to the leasing of slaves. Correspondence with Robert Barnwell Rhett and Francis B. Deane of Lynchburg, Virginia, relates to contracts, shipments, and orders for shot and shell for use by the Department of the Navv. See also Series C. Part 2. Franklin Elmore Papers.
