

INTRODUCTION

The impact of the ante-bellum southern plantations on the lives of their black and white inhabitants, as well as on the political, economic, and cultural life of the South as a whole, is one of the most fascinating and controversial problems of present-day American historical research. Depending upon the labor of slaves who constituted the great majority of the American black population, the plantations were both homes and business enterprises for a white southern elite. They were the largest, the most commercialized, and on the whole, the most efficient and specialized agricultural enterprises of their day, producing the bulk of the South's staple crops of tobacco, cotton, sugar, rice, and hemp. Their proprietors were entrepreneurs who aspired to and sometimes, after a generation or two, achieved the status of a cultivated landed aristocracy. Many distinguished themselves not only as successful planters but in the professions, in the military, in government service, and in scientific and cultural endeavors.

Planters ambitious to augment their wealth, together with their black slaves, were an important driving force in the economic and political development of new territories and states in the Southwest. As the plantations spread, their impact on local, state, and national affairs grew apace. Their commodities accounted for more than half the nation's exports, and the plantations themselves were important markets for the products of northern industry. In short, they played a crucial role in the development of a national market economy.

The plantations of the Old South, the white families who owned, operated, and lived on them, and the blacks who toiled on them as slaves for more than two centuries, have been the subjects of numerous historical studies since the pioneering work of Ulrich B. Phillips in the early twentieth century. The literature, highly controversial, has focused on questions such as the evolution and nature of the planter class and its role in shaping the white South's economy, culture, and values; the conditions of life experienced by American blacks in slavery; the impact of the "peculiar institution" on their personalities and the degree to which a distinct Afro-American culture developed among them; and, finally, the sources of the tension between the proslavery interests of the South and the "free labor" interests of the North that culminated in secession and civil war.

Research materials are plentiful. Census returns and other government documents, newspapers and periodicals, travelers' accounts, memoirs and autobiographies, and an abundance of polemical literature have much to tell historians about life on ante-bellum plantations. The autobiographies of former slaves, several twentieth-century oral history collections, and a rich record of songs and folklore are significant sources for the black experience in slavery. All the historical literature, however, from Phillips to the most recent studies, has relied heavily on the enormous collections of manuscript plantation records that survive in research libraries scattered throughout the South. These manuscripts consist of business records, account books, slave lists, overseers' reports, diaries, private letters exchanged among family members and friends, and even an occasional letter written by a literate slave. They come mostly from the larger tobacco, cotton, sugar, and rice plantations, but a significant number survive from the more modest estates and smaller slaveholdings whose economic operations tended to be less specialized.

Plantation records illuminate nearly every aspect of plantation life. Not only business operations and day-to-day labor routines, but family affairs, the roles of women, racial attitudes, relations between masters and slaves, social and cultural life, the values shared by members of the planter class, and the tensions and anxieties that were inseparable from a slave society all are revealed with a fullness and candor unmatched by any of the other available sources. Moreover, these records are immensely valuable for studies of black slavery. Needless to say, since they were compiled by members of the white master class, they provide little direct evidence of the inner feelings and private lives of the slave population. But they are the best sources of information about the care and treatment of slaves, about problems in the management of slave labor, and about forms of slave resistance short of open rebellion. They also tell us much about the behavior of slaves, from which historians can at least draw inferences about the impact of slavery on the minds and personalities of its black victims.

Deposited in southern state archives and in the libraries of many southern universities and historical societies, the number of available plantation records has increased significantly in recent decades. Our publication is designed to assist scholars in their use by offering for the first time an ample selection of the most important materials in a single microfilm collection. Ultimately it will cover each geographical area in which the plantation flourished, with additions of approximately four new collections annually. A special effort is being made to offer the rarer records of the smaller slaveholders and to include the equally rare records of the plantations in the last quarter of the eighteenth century. However, the documentation is most abundant for the operations of the larger plantations

in the period between the War of 1812 and the Civil War, and their records will constitute the bulk of our publication.

NOTE ON SOURCES

The collections in this publication are selected from the Manuscripts Department, University of Virginia Library, University of Virginia, Charlottesville, Virginia 22904. Persons interested in related manuscript collections from the University of Virginia should consult A Guide to the Collections relating to Afro-American History, Literature and Culture in the Manuscripts Department of the University of Virginia Library, compiled by Michael Plunkett (Charlottesville: University of Virginia Library, 1984).

The maps of Virginia filmed with this series are those of T.G. Bradford (Boston, 1838) and J.H. Colton & Company (New York, 1855).

EDITORIAL NOTE

Several collections selected for inclusion in this micropublication have not been filmed in their entirety. Material dating after 1865 has not been included for the Berkeley, Gilliam, Barbour, and Randolph collections, although Bound Volumes selected for inclusion were filmed in their entirety, even when entries therein run beyond 1865. Post-1865 records will be microfilmed as part of subsequent plantation records series, *Records of Southern Plantations from 1866 to 1920*. More specific information on omissions can be found at the end of the descriptive introductions for each collection. Apart from post-1865 material, omissions were typically made for printed volumes and for material so decomposed as to be illegible.

The user guide is arranged by file folder for all collections except the Berkeley Family Papers. In the original collection of the Berkeley papers, nearly every document has been given its own file folder. To make access to this material easier for the researcher, a main entry is made for the beginning of each calendar year. Also listed with the year entry are the principal correspondents and subjects for that year. In addition, specific files are itemized and indented within each year to help eliminate possible confusion. For example, a single file in the middle of a year may contain a subseries of documents covering the entire year or extending several years

beyond. An example of this type of entry is found at Reel 2, frame 0843 of the Berkeley papers for 1788. The researcher will note the two itemized folders, one for items purchased in London during 1788, and the other for an account book beginning in 1788 but extending into the early 1800s. The user will also note that, occasionally, two or more folders of the same person's accounts, bills, receipts, etc., are listed individually for the same year (see frames 0662 and 0686 of Reel 5). These are not duplicate entries, but separate folders as arranged in the original collection.

The descriptive summary of the Louisa H. A. Minor diary appearing in this user guide was prepared by Robin D. Wear of the University of Virginia Library.



REEL INDEX

Reel 1

Berkeley Family Papers, 1536, 1653-1865, Caroline, King William, Loudoun, Middlesex, and Prince William Counties, Virginia; also Arkansas, Accession Number 38-113

Both the papers and bound volumes of this large collection contain abundant material on life and agriculture in the ante-bellum Tidewater and Piedmont regions of Virginia. Finance, marketing, production, overseers, slavery, western migration, field rotation, agrarian experimentation, and animal husbandry are some of the multifarious details of several large tobacco and grain plantations represented in these papers. Social matters include purchases of household and plantation supplies, medical accounts, education, entertainment, travel, religion, and politics. Rich family and women's correspondence chart the day-to-day lives, hopes, and aspirations of over six generations of Berkeleys.

Plantations of the Berkeley family were varied and productive. Records of the Tidewater estates document the massive amounts of tobacco that were exported to England during the eighteenth and early nineteenth centuries, and then to Richmond by the 1820s. Correspondence and financial accounts with London factors indicate the balance of payments and market conditions, list items purchased abroad, and record advice on the quality of tobacco and the management of estates. Local business receipts and correspondence record the quantity of crops of corn, wheat, and garden produce, as well as the weights of hogs slaughtered, the breeding of fine horses, and attendance at races.

The Piedmont estate records reveal the advent of a grain economy centered on the markets of Baltimore, Norfolk, and Alexandria. Regular reports on grain market conditions are interspersed with sales receipts and details of wheat and corn culture in addition to milling activities. Herds of cattle, sheep, and swine were vital components of the Berkeley plantation enterprises, and the collection details their husbandry and marketing. In

addition, technological advances, transportation improvements, and the sophistication of farming techniques can be charted from before 1790 through the Civil War. Regional and local interactions are evidenced in receipts for harvest hands (including free blacks), accounts for a variety of services, and letters.

Estate names that recur in these papers include "Barn Elms," the home of four generations of the Berkeley family, comprising over 1,700 acres on the Rappahannock River in Middlesex County. Other farms were also productive in the early eighteenth century and would remain in the family until well after the Civil War. These included "Lowground," "Hays," and "Goose Pond," located on the Mattaponi River in King William and Caroline counties, encompassing thousands of acres. "Airwell," in Hanover County, was another large tract that was actively farmed by family members for many generations. Further inland along Bull Run in Prince William County, "Evergreen" was a portion of an original land grant containing nearly 6,000 acres that were farmed by the family for generations. The Piedmont estates of "Aldie" and nearby "Stoke" were the Loudoun County seat of three generations of the Berkeley and Noland families.

Spanning the collection are documents relating to slavery among these vast estates, including inventories and letters from overseers. A myriad of other references to slavery occur in sales and purchase receipts, estate divisions and wills, and receipts for taking in runaways. Provisioning and clothing of slaves are amply recorded in both the papers and bound volumes.

Although these records encompass the activities of numerous members of the Berkeley and allied families, they center on seven members of the Berkeley family: Edmund Berkeley (d. 1718); Colonel Edmund Berkeley (1704-1767); Edmund Berkeley, Jr. (1730-1802); Carter B. Berkeley (1777-1827); Lewis Berkeley (1789-1853); Major William Noland (d. 1855); and William N. Berkeley (1826-1907). Various members of these families were prolific letter writers, and family correspondence highlights this collection. Female correspondents included Mrs. Frances Reid, a relative of the Nolands who received numerous letters from her daughters and other relatives; Catherine Noland; and Frances Callender [Noland] Berkeley and Elizabeth Edmonia [Churchill] Berkeley [Cooke], who were frequent and voluminous correspondents. Cynthia W. [Smith] Berkeley was a vital correspondent of the Civil Waryears and earlier.

Records of Tidewater plantations run from the 1600s through the end of the Civil War. Edmund Berkeley (d. 1718) resided in Gloucester and later Middlesex counties. He also spearheaded the family's expansion into nearby counties, although his activities are not as well documented as those of his son, Colonel Edmund Berkeley (1704-1767), who oversaw a prosperous and thriving domain from "Barn Elms" to far Prince William County. These early records are itemized and abstracted in "A Calendar of the Berkeley Papers, 1653-1767," by Francis Lewis Berkeley, Jr., found in the introductory material on Reel 1. At his death, his wife, Mary [Nelson] Berkeley, was given dower rights to the Middlesex estate. Their daughters received cash settlements and a few slaves, while the landed estates went to their sons, Edmund, Jr., and Nelson. The younger son Nelson received one-third of the residual estate and the tract of land in Hanover County on which he made his home.

Records of the Nelson Berkeley branch continue through the 1830s, while Edmund, Jr. [1730-1802], allotted farms in Gloucester, King William and King and Queen counties as a marriage settlement prior to his wedding with Judith [Randolph] [Berkeley] in 1757, received two-thirds of his father's residual estate, all of the silver plate and furniture, and later, "Barn Elms." Judith died in 1763, and in 1768 Edmund, Jr. remarried. He served as treasurer of Middlesex County in the 1780s; some documents shed light on trouble with a deputy sheriff and clerk's fees. However, Edmund Berkeley, Jr., was a determined and successful agriculturalist. Among the papers of 1792 is a letter from John Taylor of Caroline County regarding navigation improvements on the Mattiponi River, and proposing the use of slave labor on the estates in the area.

Two of Edmund, Jr.'s sons who lived to maturity are important in these papers: Carter B. Berkeley (1777-1827) and Lewis Berkeley (1789-1853). Carter B. Berkeley assumed control of the estate of "Barn Elms" shortly after the turn of the century and managed family affairs through 1819. At the prompting of relatives, he was declared insane, removed from the estate, and institutionalized in Baltimore. In 1821, Lewis Berkeley married Frances Callender [Noland] Berkeley, a daughter of Major William Noland (d. 1855) with whom he was closely allied in business.

Records of Lewis Berkeley and his father-in-law form the bulk of the collection from the 1820s through 1850. Noland was a prominent farmer and mill owner of Loudoun County, Virginia, and neighboring Frederick County, Maryland. His estate "Aldie" included a merchant mill and extensive Piedmont lands in Loudoun County. He was a staunch Democrat and a public official, serving first as Receiver of Public Monies in Arkansas Territory, 1825-1827, and subsequently as Commissioner of Public Lands in the District of Columbia. His son, Charles Fenton Mercer Noland, served in the Rangers prior to attaining a commission in the U.S. Light Dragoons. Letters in the early 1830s reveal much on frontier conditions, politics, and the organization of the Light Dragoons. Charles Fenton Mercer Noland later

delivered the first constitution to the state of Arkansas, settled in Batesville, and provided a commentary on Arkansas affairs through his letters over a thirty-year period.

Lewis Berkeley purchased the "Aldie" estate during the 1820s and lived there until his death, while managing the Tidewater estates from afar. Overseers' letters document the operation of the Tidewater plantations, and accounts with factors record their produce. Lewis Berkeley had four sons: Edmund, William N., Charles Fenton, and Norborne. They attended Episcopal High School, Virginia Military Institute, and/or the College of William and Mary during the 1840s. The activities of William N. Berkeley (1826-1907) are particularly well documented at "Aldie" after the death of his father. In addition to letters from his schoolhood friends and business agents, he maintained a particularly voluminous correspondence with his wife, Cynthia W. [Smith] Berkeley in the 1850s and 1860s. Another frequent correspondent was his brother-in-law, Crawford E. Smith, a planter of Saline County, Missouri.

Civil War letters of the Berkeley family are particularly rich, shedding light on diverse military campaigns, the home front, and life in the prison camps of the North.

Bound volumes of the Berkeley family collection are both interspersed among the papers and isolated at the end of the collection. Bound volumes include the activities of Major William Noland, Lewis Berkeley, and William N. Berkeley. Bound volumes--oversize concern the activities of Colonel Edmund Berkeley, Carter B. Berkeley, and Elizabeth Edmonia Churchill, as well as unidentified tayern accounts.

N.B. Material not included in this collection are: folders containing genealogical data and coats of arms of the Berkeley and Spottswood families; Gregory's, *Legacy to His Daughters*, 1784 (printed); Alfred W. Arrington, *Desperadoes of the New World*, 1849 (printed); two shelf feet of papers dated 1866-1986; and twenty volumes dated 1866-1930 (post-Civil War).

Gilliam Family Papers, 1802-1865, Dinwiddie, Chesterfield, Brunswick, Surry, and Sussex Counties, Virginia; also Alabama, Accession Number 2608

This is the first and largest of three related accessions of Gilliam family papers. It consists of personal and family correspondence, various accounts and bills, political correspondence, and slave trade papers. The accounts and receipts chronicle the daily financial activities of the family. Pre-Civil War accounts pertain to the operation of mid-sized tobacco farms and plantations in Sussex and Surry counties and a large tobacco and wheat estate known as "Burnt Quarter" in Dinwiddie and Chesterfield counties, Virginia, as well as cotton plantations in Greene and Marengo counties, Alabama. Papers relating to slavery cover the years 1828 through 1865 and include the hiring out and trading of slaves, purchases, slave provision accounts, and other papers revealing daily occurrences. Personal and family correspondence are concentrated in the post-1850 years. Political

correspondence is thin in the pre-Civil War era, but does portray the "Know Nothings" in Dinwiddie County during 1856 and other events. William Gilliam is represented in the earliest documents, followed by documents of his son John W. Gilliam, who was the most prominent member of the family until his death in 1853. John W. Gilliam's name and that of his son, Joseph P. Gilliam, dominate the slavery papers. John W. Gilliam also represented Dinwiddie County in the state House of Delegates during 1847-1848, vigorously criticizing the Mexican war. Upon his death, his wife Mary E.C. Gilliam carried on the family affairs. Her name frequently appeared on the accounts and correspondence of the 1850s and 1860s.

Civil War papers are rich in family and personal correspondence, particularly that of Rosa G.C. Barnett with various women as well as soldiers at bivouacs in Virginia and North Carolina. Overseer and factor correspondence also continued in these years, eliciting details of agricultural activities in the 1850s and 1860s in Dinwiddie County, Virginia, and Marengo County, Alabama. Army quartermaster activities in Dinwiddie are also well documented.

N.B. Omitted from this collection because they are outside the time period covered were two Hollinger boxes of papers dated 1866-1926 and an undated notebook with post-bellum accounts.

In addition, a plantation journal of Mary E.C. Gilliam can be found in the Mary E.C. Gilliam collection at Duke University, microfilmed as part of Series F, Part 3 of UPA's publication series, *Records of Ante-Bellum Southern Plantations*.

An 1836 mill lease agreement between John W. Gilliam and the Boisseau sisters concerns a Petersburg mill. Court records of 1854 to 1857 portray the accounts of Mary E.C. Gilliam as guardian of Joseph P. Gilliam. An undated speech of John W. Gilliam is a polemic on the issue of the accession of Texas in the era of James K. Polk.

Other letters include overseers' correspondence and accounts of cotton sales in Alabama, wheat crops in Virginia, the use of quano, and other matters.

Barbour Family Papers, 1775-1858, Orange and Albemarle Counties, Virginia, Accession Number 1486

Largely the personal and financial papers of James Barbour (1775-1842) and B. Johnson Barbour (1821-1894), this collection is divided into three

series: papers, bound volumes, and oversize items. The collection comprises financial and legal papers, printed material, correspondence, account books, agricultural journals, slave inventories, and commonplace books. However, the material does not contain any of the official papers of James Barbour's service in the U.S. Senate, in other positions in the national government, or as governor of Virginia.

Among the personal letters, noteworthy items include: James Barbour's complaints concerning his son James's extravagance while attending Harvard and reference to the hardships during the War of 1812 (October 19, 1815; July 25, 1816); slaves and slavery (September 2, 1822; May 22, 1824); rail travel from Virginia to Florida and the importance of cotton to the South (February 11, 1857); letters of Frank Ruffin to B. Johnson Barbour regarding friendship, social activities, and agriculture (1850s); and plans for construction of the Orange County Court House (1858). Courtship letters of B. Johnson Barbour to Caroline H. Watson include a letter from his mother, Lucy [Johnson] Barbour, to his bride-to-be (ca. 1844).

The agricultural and plantation records in the bound volumes are the highlight of this collection. James Barbour kept meticulous, albeit sporadic, records of his estate at Barboursville. These records include daily tasks assigned slave laborers. The central volume is the agricultural journal of James Barbour and B. Johnson Barbour, 1811-1941, including some genealogical notes by Caroline H.B. Ellis. Other volumes concern mercantile activities and a distillery.

The oversize items include a political broadside regarding the William Henry Harrison presidential campaign and a copy of a portrait of James Barbour.

Randolph Family Papers, 1790-1864, Albemarle County, Virginia, Accession Number 8937b

This collection consists mainly of letters addressed to Thomas Jefferson Randolph (1792-1875) and his father-in-law, Wilson Cary Nicholas, with some additional items concerning Thomas's father and mother, Thomas Mann Randolph (1768-1828) and Martha [Jefferson] Randolph (1772-1836), and his grandfather, Thomas Jefferson (1743-1826). Letters discuss agriculture, navigation improvements, politics, slavery, and social matters. During 1849, Thomas Jefferson Randolph was taxed on 2,481 acres in Albemarle County, and on 46 tithable slaves.

Transportation improvements in which Randolph was involved include the Rivanna Navigation Company and the Blue Ridge Railroad. Items of particular social interest include a description of a duel involving Frank G. Ruffin in 1834, and a challenge to a duel between Robert Stanard and Alexander Rives in 1837. Still other correspondence concerns the University of Virginia.

Political correspondence pervades and includes discussions of the Panic of 1819, slavery, slave colonization, President Andrew Jackson, and other issues. Many of the premier Virginia politicians of the day are represented, including Governor Wilson Cary Nicholas. Principal correspondents include members of the Randolph, Nicholas, Gilmer, and Rives families, as well as John Hartwell Cocke, Alexander Garrett, and Duff Green.

The collection is divided into three sections: Papers; Papers--n.d. and miscellaneous; and Papers--bills and receipts.

Diary of Louisa H.A. Minor, 1855-1866, Albemarle County, Virginia, Accession Number 10685

Louisa H.A. Minor, born April 13, 1833, was the youngest child of Samuel Overton Minor (-August 30, 1838) and Lydia Laurie (Lewis) Minor (February 15, 1795-August 8, 1833). After her parents' deaths, Louisa was raised by her mother's sister, Mary Walker (Lewis) Leitch Anderson (March

25, 1793-June 21, 1872) of "Pant-Ops," Albemarle County. Throughout the diary, Mary Walker and David Anderson are referred to as "Ma" and "Daddy."

Louisa's diary, about 440 pages, kept from September 1, 1855 to December 29, 1866, reveals her personal feelings as well as both routine and extraordinary events in the lives of herself, her family, and friends. She often writes about her weekly activities, especially church attendance and social interactions with relatives and friends. References often concern marriages, births, illnesses, deaths, visits, and Louisa's impressions about individuals and the events in their lives. She also writes her own poetry and quotes verses of others, as well as her thoughts on books she read and church sermons.

There are frequent references to members of the Minor family, especially Louisa's brothers and sisters and their families. While Louisa was still a small child, her father and several offspring migrated to Missouri, while others, including Louisa, remained in Virginia. During the period of the diary, the following siblings were living: Mary Overton (December 4, 1812-), Garritt (November 15, 1815-), William Woolfolk (March 10, 1817-May 3, 1885), James Hunter (November 15, 1818-April 12, 1862), Samuel Overton (May 12, 1820-March 24, 1880), Nicholas Peter (August 25, 1822-), Bettie Lewis (September 12, 1825-), and Sallie Watson (January 3, 1829-March 1873). There are also references to more distant relatives as well as friends of the Anderson, Carr, Davis, Gilmer, Leitch, Lewis, Macmurdo, Meriwether, Minor, Randolph and Terrell families.

Louisa was quite religious, often attending church several times a week, and visiting churches of different denominations, including Grace Church, the "Brick Church," the University Chapel, St. Paul's Church, the "Monumental" Church, and an "African" church in Richmond. She heard some of the prominent clergymen of the time, such as Ebenezer Boyden, John Albert Broadus, Dabney Carr Davis, Richard Terrell Davis, Richard Kidder Meade, Bishop William Meade, Liberian Bishop John S. Payne, and Joseph Pere Bell Wilmer.

There are references to and some descriptions of places visited and events attended, including the Virginia State Fair in Richmond, 1857 and 1860. Louisa often visited the nearby estates of family and friends-"Castalia," "Cloverfields," "Kinloch," "Locust Hill," "Music Hall," "Orange Dale"--relating occurrences at them. There are mentions of the funeral of the artist John Toole (March 1860), the annual celebrations of the Jefferson Society and the Washington (Literary) Society at the University of Virginia, as well as other events at the University. Information on Charlottesville is found throughout the diary.

Prior to the beginning of the Civil War, references to blacks included news of freed servants sailing from Norfolk to Africa (December 1856), and later accounts of many of their deaths along the way (April 1857). Also during this time there was much political discussion and talk of insurrections generally (December 1856) and of insubordination among the servants at Music Hall (August 1857). Louisa's feelings toward the uprisings was probably indicative of the way the Southerners felt during this time. She often referred to the closeness of the family and the servants, and seemed to have no understanding of any rebelliousness. This lack of understanding seems evident in December 1865, when she wrote that the "freedmen seem to be having all the fun and goodies." She wrote of their changing status, their unwillingness to attend to the family's wants, and their still receiving daily allowances--all with the belief that they had been treated fairly (December 1865).

During the Civil War, Louisa wrote about occurrences in more detail, although much of the news was indirect, through hearsay or letters. In late 1860, Louisa wrote about the realization of war, and the companies of infantry "drawn out in all 'the pomp and circumstance of war'." Throughout the war she often expressed the feelings of Southerners toward the Union, the victories and losses of the Confederate Army, heroes such as "Stonewall" Jackson, destruction of land and transportation modes, and the changing status of blacks.

From January 1861 through April 1865, Louisa reported on the progress of the war. She mentions that when Jackson's troops marched in June of 1862, she spent the whole day feeding soldiers, gave up her bed at night, and was paid a visit in the parlor by General Ewell, "a funny old fellow . . . [with] the simplicity and heart of a child . . ." She also reports on a Christmas dinner given to over 1,200 soldiers at the Delevan Hospital, Charlottesville, and Custer's diversionary raid on Rio Hill on February 29, 1864. As time progressed, the effects of the war became more evident on Louisa as more and more of her family and friends and the surrounding area were affected directly. During late 1864 and early 1865, Charlottesville was more involved in the war, with Union raids and destruction of property. Louisa gives a fairly full account of federal troops passing through Albemarle County in March 1865, and describes the hardships of the first year of Reconstruction.

Also included is a bequest of Mary Walker [Lewis] Anderson to Louisa H.A. Minor, dated April 23, 1871.

Divisions within individual collections include volumes and papers, and in some cases, further breakdowns indicate types of papers such as correspondence or notes and receipts, as well as oversize volumes. Within these classes of material, classifications are made by chronology. University Publications of America plans to offer a separate series of plantation records from emancipation into the early twentieth century, which will complete many of the collections included in this publication that have been terminated at the end of 1865.

Southside Virginia Family Papers (Reid Papers), 1748-1918, Bedford, Campbell, Charlotte, Franklin, Pittsylvania, Halifax, and Mecklenburg Counties, Virginia Accession Number 550

These papers, compiled by a private collector, document lawyers, preachers, and small planters from the tobacco-growing regions of south central Virginia near North Carolina known as "Southside" Virginia. Of the 55 subseries in the collection, 35 pertain to individuals or families, while 20 relate to subjects or classes of material.

Although the material primarily deals with ante-bellum events, there is also a wealth of post-bellum material that, in contrast with other parts of UPA's series on Southern plantations, has not been omitted from the microfilm. Some of the larger subseries containing pre- and post-1865 materials include: Barksdale family, correspondence and miscellaneous letters; County Line Church of Christ (Baptist) and papers on Virginia Baptist Churches; Hubbard family, miscellaneous bills and receipts (two divisions); and Spragins family.

In addition to the subseries on slavery, there are numerous references to slavery scattered throughout: doctors' bills for treating slaves, receipts for boarding slaves, receipts and bills of hire for slaves, wills, estate divisions, and agreements and receipts for the transportation and sale of slaves. The papers on slavery subseries includes emancipation papers, sales receipts, reports of market prices, and bills of hire. One remarkable letter of January 9, 1840, to Alexander Cunningham from the sheriff of Marion (Smyth County), Virginia, describes the capture of a runaway slave who had been travelling with a white woman. The slave had been dressed as a woman and his female accomplice as a man. According to the sheriff, the white woman was liable for heavy penalties because of her involvement in the scheme, to be administered at the discretion of the slaveowner in their home county of Halifax.

Agricultural activities in the "Southside" region are amply documented. Overseers' contracts, tobacco receipts, and directions for curing tobacco are a few of the many types of papers found throughout the collection. In addition, information concerning the industry of raising and marketing corn, oats, wheat, and livestock as vital adjuncts to the staple tobacco culture is found in the correspondence of these small to mid-size planters.

In some instances, the collection provides valuable documentation on plantation affairs outside Virginia, such as in the subseries of W.P. Maxey Papers. The Maxey papers span three subseries: Correspondence, Miscellaneous Letters, and the W.P. Maxey Papers. Maxey, a storekeeper of Brandon (Rankin County), Mississippi, wrote to his sister in the Old Dominion. His letters show his continued affection for his native state, the peregrinations of the Maxey family, the dislocation caused by the Civil War, and the changing roles of storekeepers, planters, and freedmen in the cotton South.

Three divisions refer exclusively to religious matters: County Line Church of Christ (Baptist); Reverend John Dowdy; and Papers on Virginia Baptist churches. In addition, many other divisions--those of individuals and families or subjects and including but not limited to the Correspondence and Miscellaneous printed material divisions--contain details on religious matters.

Bruce Family Papers, 1746-1865, Halifax, Pittsylvania, and Roanoke Counties, Virginia; also Alabama, Accession Number 2692

The principal figures of this collection are James Bruce (1763-1837), James Coles Bruce (ca. 1800-ca. 1864), Alexander Bruce (ca. 1833- ca. 1900), and their wives, relatives, and business associates. Tobacco, cotton and grain culture, milling activities, estate management, plantation and slave management, major and minor financial matters and mercantile operations are some of the many topics thoroughly documented in this extensive collection. The woman's voice and family matters are also pervasively documented. This large collection offers a detailed and often vivid picture of the region known as "Southside" Virginia.

Regular interactions of large and small planters with grist mills, country stores and tobacco merchants can be charted through the accounts of the Bruce family's Meadsville Mills and other mercantile concerns. Other rare glimpses of free blacks and harvest hands are also evident in the copious Bruce family records, which include business accounts, business papers and correspondence, indentures, personal and family correspondence, estate records, and overseers' reports and accounts.

The 40 bound volumes in the collection offer one of the most thorough running accounts in existence of the financial affairs of large ante-bellum plantation operations. These extraordinary records include letter books, plantation journals, personal ledgers and journals, Meadsville Mills' ledgers and journals, mercantile account books, and commonplace books.

Bruce family plantations covered in the collection include "Halifax," "Waverly," "Tarover," and "Berry Hill." In addition, the Bruces held many large and small parcels of land that were farmed or rented in Charlotte, Halifax, Pittsylvania, and Roanoke counties, Virginia, as well as in

neighboring counties in North Carolina. Members of the family also speculated in western lands and operated a large cotton plantation in Alabama through overseers.

James Bruce was among the wealthiest persons in America, his estate amounting to over \$4,000,000. He began merchandising in the Petersburg area, later settling in Halifax and operating through many partnerships in that region of Virginia. His second wife was Elvira A. Bruce, who is a frequent correspondent in the Papers.

James Coles Bruce is perhaps the best documented person in the collection. His early education in Virginia was followed by stints at Harvard University during 1826 and at the University of Virginia during 1828. Married in 1829 to Eliza Wilkins, he served in the state legislature several times, and travelled extensively throughout the South, while managing the home estates. Charles Bruce was his half brother, and Ellen Carter [Bruce] Morson and Sarah [Bruce] Seddon his half sisters. The children of James Coles Bruce were numerous and all apparently well educated at private academies and public institutions such as Virginia Military Academy.

An overseer's inventory of James C. Bruce's plantation on the Dan River in Pittsylvania County indicated that there were 31 slaves in addition to horses, cattle, sheep, hogs, and numerous tools and provisions. Following the death of his father James Bruce in 1837, James Coles Bruce became much more active in business affairs. A noteworthy list and inventory (over 130 individuals) on the plantation of Messrs. Bruce, Seddon, and Williams in Alabama during 1849 details occupations, personal habits, values, and whether native or African-born. Registers of Negroes of the Bruce family from 1852 record hundreds of bondsmen in various locales and provide similar evaluations and personal assessments for individual slaves. Inventories of his household possessions from 1851 depict the personal effects of this wealthy plantation family.

The education, formative years, and early agricultural activities of Alexander Bruce, a son of James Cole Bruce, are well documented. Alexander married Mary Evelyn Anderson in 1852 and over the next 13 years they had several children. Correspondence between he and his wife is abundant and contains news of both family and friends. They maintained an active correspondence from the ante-bellum period through the Civil War.

Regular women's correspondence begins to surface in the collection in the 1820s, and includes that of Elvira A. Bruce, Eliza [Wilkins] Bruce, Ellen Carter [Bruce] Morson, Sally [Bruce] Seddon, Mary Evelyn [Anderson] Bruce, Maria Bruce, Ellen Bruce, and Sally Bruce. Other correspondents include Mrs. Mary Anne Anderson, Fanny Anderson, Josephine Anderson, Mrs. Sarah E. Carrington, Mrs. Mildred E. Carrington, Sally Brodnax, and

Ann Green. Husband-wife correspondence of Elvira A. Bruce, Eliza [Wilkins] Bruce, and Mary Evelyn [Anderson] Bruce details household and cultural activities of the ante-bellum period. Incoming letters from their husbands often provide observations from business trips to the north, south, and west; on visits to spas; and on affairs in Richmond--particularly when the legislature was in session. Religious and devotional reflections are recurrent themes, as are health concerns, family news, and local events.

Father-son letters typically concern educational activities, agricultural problems, parental advice, and worldly successes. Family and social matters are frequent topics of discussion. Occasional moral rebukes and plaudits provide insight into the value system of the planter class.

Political correspondence touches on many issues, including internal improvements, colonization programs for free blacks, the secession crisis, and the Civil War. The most important vein of political correspondence is that between William Ballard Preston and James Cole Bruce, who served in the Virginia House together, and long remained friends.

Local business firms documented throughout the collection that shed light on the mercantile activities of the Bruce family include Bruce & Hagood, Bruce and Sydnor, John Chappell & Co., William B. Williams & Co., James S. Easeley & Co., and William Bailey & Co. The family dealt primarily with Joseph Marx & Sons, merchants of Richmond, for the marketing of tobacco and for various other services. Papers of the Roanoke Navigation Company are numerous during the 1820s and 1830s.

N.B. A complementary collection of Bruce Family Papers, 1792-1865, has been microfilmed from the holdings of the Library of Congress, in UPA's publication, Records of Ante-Bellum Southern Plantations, Series C, Part 1. Omitted from the Bruce Family Papers, acc. 2692, were several journals and ledgers that were badly decomposed. Among these are James Bruce's ledgers from 1811-1819, 1814-1828, 1814-1819, and his journal dated 1808-1817. Also badly decomposed are: Bruce and Hagood, Ledger, 1822-1824; Samuel Carter, Meadsville Mills Journal, 1813-1840; James Bruce, personal journal, 1832-1838; and James C. Bruce's ledgers dated 1838-1846, 1851-1862, and 1861-1863. Other items not included are printed tables of interest rates, 1828; James C. Bruce and Alexander Bruce, Daybook, 1859-1888; an undated index correlating to no volume; and four Hollinger boxes and several volumes dated 1866-1905.
