The Landmark series consists of hardbound volumes with gold-stamped lettering on the spine, and containing approximately 750 pages. A table of contents lists the cases included in the volume and the briefs and arguments presented in each case.

The briefs are facsimile reproductions of the briefs that were filed at the Supreme Court and contain the plaintiffs' and respondents' main arguments, plus the amicus curiae arguments. Except for the omission of appendices and certificates of service, they have been printed in their entirety. The sources of the oral arguments are the transcripts at the Supreme Court Library.

In addition to the briefs and oral arguments, Landmark includes petitions for writ of certiorari, which request the Court to hear a case; supplemental memoranda submitted to update or expand on a brief; motions to affirm, requesting oral responses to points made by the opposing attorney or addressing concerns voiced from the bench.

The pagination of the original documents has been retained. Additionally continuous pagination has been added in the margins of each page.

Cases selected by distinguished legal scholars

Gerhard Casper and Kathleen M. Sullivan are the general editors for the Landmark series.

Gerhard Casper, named president of Stanford University in 1992, also holds appointment there as a professor of law. He came to Stanford from the University of Chicago, where he taught law since 1996, serving as dean of the law school for eleven years and as provost of the university since 1989. From 1977 to 1991 he was coeditor of *The Supreme Court report*.

Kathleen M. Sullivan, Dean of Stanford Law School and Richard E. Lang Professor of Law and Stanley Morrison Professor of Law. She came to Stanford from Harvard University, where she taught constitutional law since 1984. From 1982 through 1984, Dr. Sullivan held a litigation practice in Boston (appellate constitutional law and criminal defense).
