AREA OF LAW AT A GLANCE

Labor law relates to union activities, dealing with unionized workplaces and employee representation. Labor law attorneys deal with issues of union representation and unfair labor practices. Typically, labor attorneys negotiate collective bargaining agreements, deal with attempts to establish a unionized workplace, manage various union activities, and participate in labor arbitration proceedings. Employment law involves the rights of individual employees, as opposed to unions. Employment law attorneys deal with issues of termination, discrimination, harassment, and retaliation. Typically, employment attorneys are litigators and often provide counseling/advice on workplace issues.
