This Directive intends to harmonise excise tax levels across member states on tobacco products sold in the EU, and sets the overall minimum excise duty for cigarettes at no less than 60 EUR for 1,000 cigarettes from 1 July 2002, and no less than 64 EUR from 1 July 2006. It also changes the definition of cigars and cigarillos to the effect that the application of a lower minimum rate (5% of the retail selling price or 11 EUR per 1,000) is limited to those labour intensive products for which it was originally intended. *Implemented*.

on access to, and interconnection of, electronic communications networks and associated facilities

Transposition Deadline 24.07.03 (art 18)

This Directive serves to harmonise how member states organise access to electronic communication networks and associated facilities through the creation of a legal framework for a free internal market and ensuring the interoperability of the different networks and fostering the consumer's interests. The Directive replaces the former Open Network Provisions and is applicable to all forms of communications networks carrying publicly-available services. It seeks to apply general competition rules as an instrument for market regulation. The key focus is to provide free and unrestricted access to communications networks and to prevent any bottleneck that may hinder the development of new innovative services that could eventually benefit the end-user. *Implemented*.

This Directive serves to harmonise and simplify the rules and conditions for authorising electronic communications networks and services, and replaces the old licensing system with a new general authorisation from which a number of rights are derived. Individual authorisations are also made available under certain conditions defined in art 6 and the Annex to the Directive. The Directive applies to all networks and services whether public or private. *Implemented*.

It is the aim of this Directive to establish a harmonised framework for the regulation of electronic communications and services. It introduces general principles and defines the regulatory scope, and contains basic definitions which are referred to in other Directives which supplement this Directive to form the Telecom Package (comprising the Access Directive 2002/19/EC, the Authorisation Directive 2002/20, the Universal Service Directive 2002/22 and the Privacy and Electronic Communications Directive 2002/58). The Directive also establishes general provisions concerning the National Regulatory Authorities, requiring member states to guarantee independence, impartiality and transparency.

This Directive establishes a minimum obligation for telecommunications operators to make their services available to all users. It sets minimum standards and objectives for member states and operators and establishes users' rights with regard to aspects such as accessibility, service levels and transparency in pricing and tariffs. Member states must also equip their national regulatory authority with the necessary remedies to impose obligations on operators and, in case of dispute, the authority must provide a transparent and inexpensive out-of-court resolution procedure. *Implemented*.
