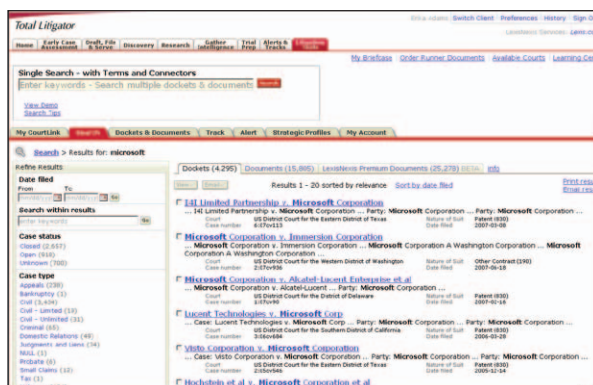
## How to Use CourtLink Single Search:

Access CourtLink Single Search via:

- The home page of LexisNexis® Total Litigator, at litigator.lexisnexis.com
- Any page within CourtLink, at courtlink.lexisnexis.com
- The Gather Intelligence tab on LexisNexis Total Litigator, by selecting the Investigate an Expert option

1. Enter your search terms in the Single Search box. To review the search connectors and search operators available, click the **Search Tips** link.
2. Review your results in two tabs—one for dockets and one for documents.

Results returned in your search can then be filtered (through the left-side options), at no additional charge, to narrow down the dockets and documents to particular case types, jurisdictions, specific search terms and more. Start your search as broadly as you like, and then work within your results set to find just what you need.

1. Access Expert Witness Verdicts & Settlements (including IDEX) through *lexis.com*®:
