Key features:

- Most importantly, **fourteen custom search templates help you access more relevant filings more efficiently.** Each template is tailored for a specific type of filing and narrows your search automatically by offering drop-down selections and filters that correspond to the information in that filing. If you know exactly which type of filing contains the information you need, you can use the appropriate template to search only that type. You can even limit your search to specific sections of the filing.

For example, 10-K, 10-Q, and 8-K templates allow you to search the most critical filings and to narrow your search by the section of the filing that would contain the

relevant information. Each template mirrors the structure of the particular filing, helping you find and move directly to the information you need. So, if you want to see which companies reported legal proceedings on their most recent 10-K, you can narrow your search to just that section in just that type of filing.

The enhanced gateway includes:

- Corporate Filings: 10-K, 10-Q, 8-K, proxy statements
- Foreign Company Filings
- Mutual Fund Filings
- Financial Comparison Charts
- Ownership Reports
- IPO and Secondary Offering Materials and Reports
- Person Search
- Enhanced Printing and Downloading

These filings are from 1994 forward, with the exception of IPO filings, which start in 1996.

... or from within the **Antitrust & Trade, Banking, Commercial, Corporate, Corporate Counsel, or Mergers & Acquisitions** area-of-law pages. In addition, you can access the gateway from the **News & Business** tab. There are also access points from corresponding Practice Centers.
