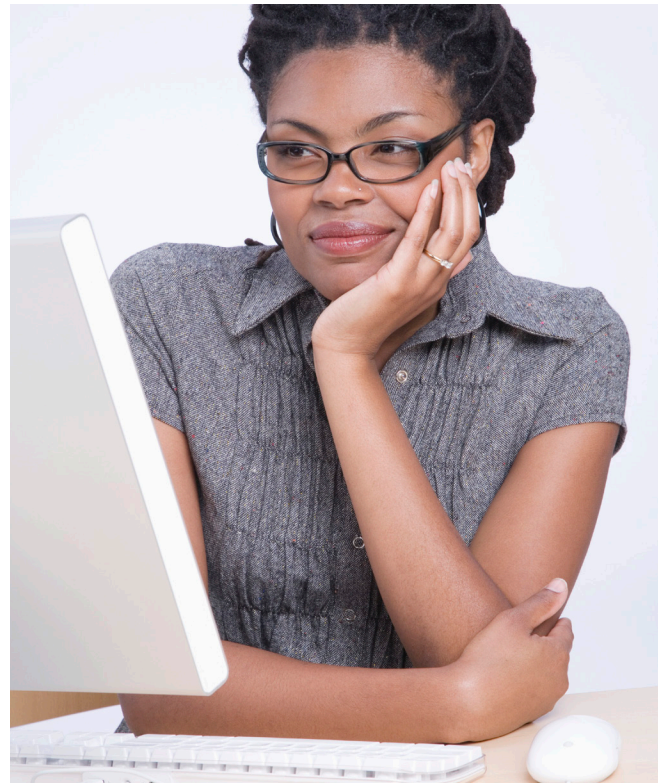

The visual and intuitive **My Workspace carousel** at Lexis Advance will help transform the way you conduct and manage your legal research. On your Lexis Advance landing page, just click the panel you wish to view. It rotates front and center, and you're ready to work.

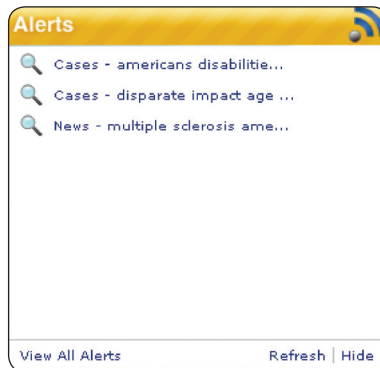


Work Folders

The My Folders panel will help you keep all your results organized in one place. Create folders—just click the New Folder link—and save search results, documents, links and notes.¹ (You can also save search results, your annotations and search history to folders as you research so you can get to the facts again quickly.)¹

You can **create as many folders and subfolders as you need** and save items across all folders such as full documents, excerpts, annotations and searches.¹

Saved documents that are part of your subscription **remain in your folder until you remove them**. Items you purchase on a transactional basis remain in your folder for 90 days. (You'll see an expiration notation on these documents in your folders.)



Alerts

Set up an alert on your search or the *Shepard's*® Citations Service report you want to follow, and monitor the changes that occur. (How? Click the **Options link** next to your search at the top of your results screen.) Set the duration of your LexisNexis alert, e.g., how many weeks you want the alert to update. And choose the frequency you need—daily, business daily, weekly or monthly.

When there is a change **you will be notified right in your Alerts panel or via email if you choose**. Your Alerts panel also gives you quick access to manage or edit your alerts.



Recent and Favorite Filters

Do you search regularly in the same jurisdictions? Do you filter your results to specific practice areas? Or maybe 9 times out of 10 you're looking for news updates as opposed to case law.

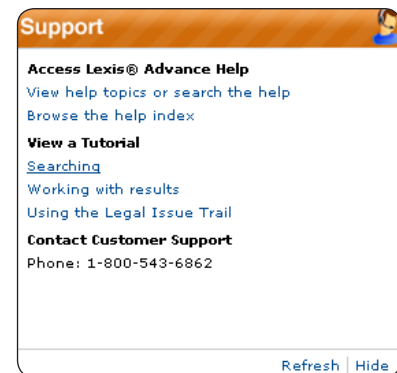
Lexis Advance makes that simple. When you **select specific pre-search filters—content types, jurisdictions or practice areas—beneath the red search box, those filters are saved automatically** in your Recent & Favorite Filters panel. To use again, just open your Filters panel and click on the filter you want to use. The red search box is now ready for your search words. To make a filter a favorite, click the star outline.



Search History

If you get interrupted and need to retrieve your search results quickly and easily, go to Search History and review your search history, **including activities such as searches, emails, downloads, prints, alerts and more**. Search History provides you with an efficient way to manage your results so you can see where you left off in your research and it allows you to eliminate rework.

Your Search History panel shows **your last 10 activities**. But click **List View** and go to your full search history—a **90-day archive of research activities**.

View inline images in Trademark Trial and Appeals Board decisions

The LexisNexis collection of **Trademark Trial and Appeal Board** decisions now includes **inline images**! Decisions from April 4, 1996, that offer references to illustrations now display the images on the screen at *lexis.com*, within the context of the decision. Images are available whether you retrieve the case via a search, via GET A DOCUMENT or via an alert.

That means you will not see phrases such as "SEE ILLUSTRATION IN ORIGINAL." Rather you'll see the illustration itself. Here's an example: In *Teletech, Inc. v. TeleTech Holdings, Inc.*, 2010 TTAB LEXIS 204, when the text discusses the logo for Teletech, Inc., the image of the actual logo appears as:



To ensure complete accuracy and the highest quality, only decisions from the original TTAB source were used for enhancing the decisions on the Lexis® service. At this time, most decisions from April 4, 1996, through current are available from the official TTAB source. Earlier decisions will be enhanced with inline images as original source decisions become available from the official source.
