What's covered

Sanctions & Watchlists cover information compiled from multiple authorities and include domestic and global sanctions, plus nearly 1,200 watchlists originating from more than 80 countries translated from multiple languages covering:

- White-collar crimes
- Crimes against humanity
- Terrorist threats
- Non-financial sanctions
- Payment patterns and insolvencies
- Unauthorized business activities
- Warning lists by financial authorities
- Disqualified directors and debarred companies
- Minor penal procedures and/or civil procedures
- International warrants, national wanted persons, regional warnings, detention records and civil records
- Lists of international tribunals, anti-money laundering and anti-corruption entities
- Special lists (e.g., persons associated with the mafia, companies using slave labor, etc.)

Your organization can suffer reputational damage and/or be subject to monetary penalties, government sanctions, civil suits and enforcement actions by various regulators if found to be working with individuals or entities that appear on sanctions lists; watchlists or blacklists; or lists of excluded, disqualified or debarred persons or organizations.

This content is considered to be a crucial component of any due diligence process and a legal obligation for some, i.e., those impacted by Dodd-Frank, the Foreign Corrupt Practices Act, the UK Bribery Act and assorted financial regulations.
