## SEARCHING DOCUMENT SEGMENTS

In Lexis Advance<sup>®</sup>, all documents of the same type have a common structure, composed of natural parts referred to as segments. For example, in cases you find segments for name, date, court, opinion and dissent, among others.

You can restrict your search to a specific segment of a document, such as the name of a case opinion or the text of a statute section. Different types of documents have different segments. For example, a case doesn't have the same segments as a newspaper article.

Segment searching is especially useful when you are looking for:

- Opinions written by a particular judge
- Cases involving a specific party
- Particular words or phrases in the title of a news article
- Search terms only in the text of the section of a statute
- And many other search scenarios where answers are desired in a specific part of a document

## HOW DO I SEARCH SPECIFIC SEGMENTS?

There are two ways:

1. In the red search box, enter your search beginning with the segment name followed by your search terms in parentheses. To find opinions written by Justice Sandra Day O'Connor, enter:

## writtenby(o'connor)

2. Or click the Advanced Search link above the red search box to display easy-touse forms for 50+ document types, e.g., cases, news, codes, etc. Each field of each form represents a searchable document segment. Fill in the fields with your terms or values and watch your search build in the red search box.

Power user tip: The labels on the Advanced Search form fields may vary from traditional segment names to make the labels easier to understand. However, as you enter text into the fields, your search is built automatically in the red search box and displays the segment names you may be more familiar with. (Sample documents show available segments, too.)
