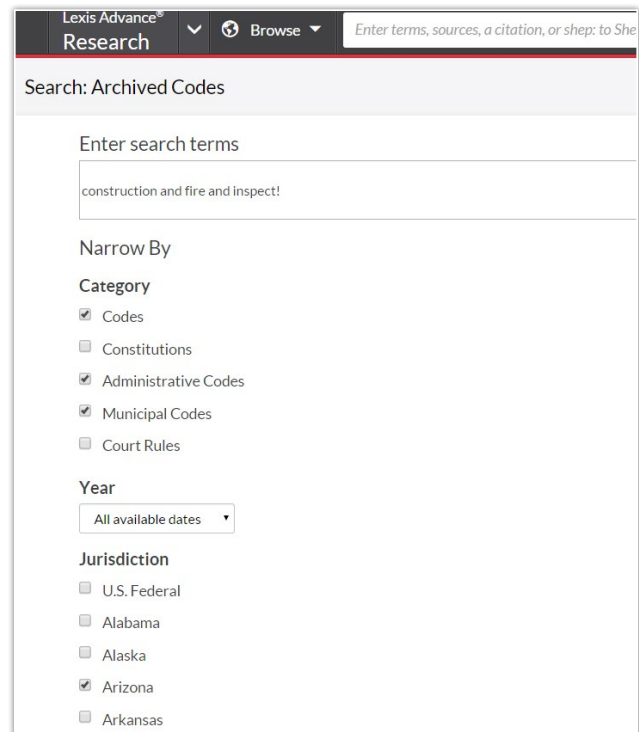
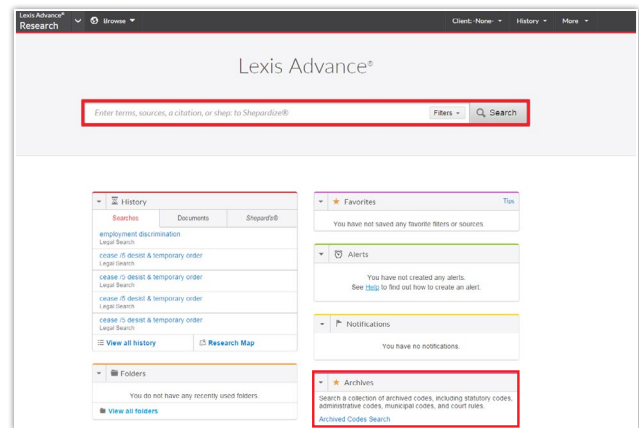

Quickly find the archived codes you need—with just a single click and a single search.

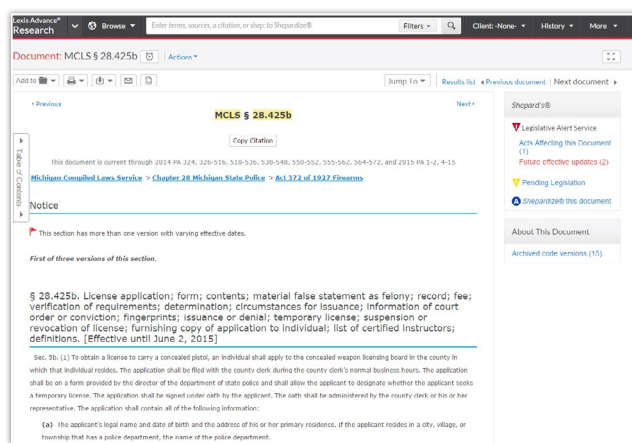

Select Archived Codes Search from the home page pod, and a search form displays that allows you to quickly select the type of code, the jurisdiction and the date from these federal, state and local sources:

- U.S. Code Service (starting 1992) and 50-states statutes (starting 2004)
- U.S. and 50-states constitutions
- CFR (starting 1982) and 50-states administrative codes (starting 2004)
- More than 2,600 municipal codes going back two years
- Federal Court Rules from 1992 forward
- State Court Rules going back two years
