Strategic Use

Gather information to analyze long-term criminal activity.

Basic Information:

Start with a locator search

From the LexisNexis Law Enforcement Solutions Page at *www.nexis.com/lawenfsolutions*:

SELECT:	Find a Person
SELECT:	a permissible use from the pull-down list
ENTER:	any information you have in the fields provided (use a case ID if desired)
CLICK:	Search

Review search results. To investigate a name further, select: Next Steps. Select View Sources and look for the most current sources, including PSRCH2 Person Locator – Nationwide and EDA – Electronic Directory Assistance.

Other options that may be available are:

- Find persons associated with addresses
- Find neighbors at this address
- Find records associated with this Social Security number
- Find persons associated with this phone number

 SELECT:
 a permissible use (one of the blue links)

 ENTER:
 the person's name (in *lastname /3 firstname* format), Social Security number, address, telephone number, and/or date of birth

 CLICK:
 Search

Review search results. Once you see targets that appear pertinent, check the individual sources from which they came.

If desired, you can then run additional searches using information found in the previous search results. Search using:

- Address, to find others who live or have lived there
- Social Security number, to find other places the person has lived
- Street name along with ZIP code or city and state, to find names of neighbors

CLICK: Click to visualize this report

Zoom in, then click and drag to move icons for easier viewing. Copy and paste visualization to an image-editing program:

- Place cursor outside the visualization area of the screen
- Press the print screen key
- Open your image-editing program (Microsoft[®] Paint, for example)
- Paste visualization screen
- Save the image
- Copy just the visualization
- Paste it into either your word-processing program or Microsoft PowerPoint[®]

You'll then be able to use that program's editing features to add information to the visualization.

Tactical Use

Scenario: A police office calls and asks you to check out a Robert Nolan with a car with license plate number HTG 101* parked on the street. They want an address to make an arrest. You have an hour and must verify sources of any information you find.

Basic information:

First, check your internal sources for Motor Vehicles.

Also, go to the LexisNexis Law Enforcement Solutions Page at *www.nexis.com/lawenfsolutions...*

SOURCE: Motor Vehicle Registrations

ENTER:	the person's name and plate/tag number (use a case ID if desired))
CLICK:	Search

Or LexisNexis Public Records at *www.lexis.com*:

- **SOURCE:** Public Records > Public Records > Personal Property Locator > All Motor Vehicle Registrations
- SEARCH:
 lastname /3 firstname AND plate/tag number

 CLICK:
 Search

Next, perform a person locator search to verify address information, either from the LexisNexis Law Enforcement Solutions Page at *www.nexis.com/lawenfsolutions* or LexisNexis Public Records at *www.lexis.com* as indicated on the first page.

General Notes/Tips

Keeping a search history

The LexisNexis services now save your searches automatically for 30 days. Use Print History for a permanent record of work on your project.

Search tips

To look for name variations or misspellings, use the OR connector between variations, and/or use universal characters (* and !) to allow for additional variations. For example:

- greenfield OR greenfeld OR greenfeldt
- m*yer OR meijer OR maier OR myer
- *dian!* OR *dyan!*
- thom! OR tom

To find information on a person for whom you have a partial Social Security number, you can use universal characters. For example:

- 12*-45-6789
- 123**6789
- 123-45-67!

The **Edit Search** feature in the Law Enforcement Solutions Page lets you modify your search.

When you use Find a Person (on the Law Enforcement Solutions Page) and use date of birth or age range in your search, your results will appear in order by that criterion.

You will see different SmartLinx results when searching with Terms and Connectors than when you use the Fill-in method. A Terms and Connectors search will look for your terms anywhere in a document, whereas Fill-in searches for your terms only the segments that correspond to the filled-in fields.
