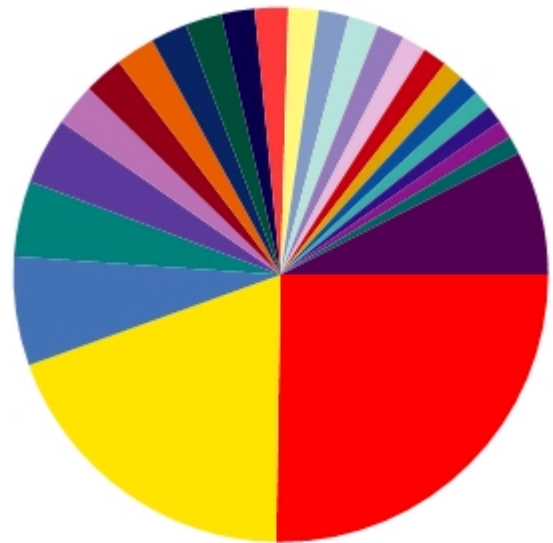

Case Count by Jurisdiction



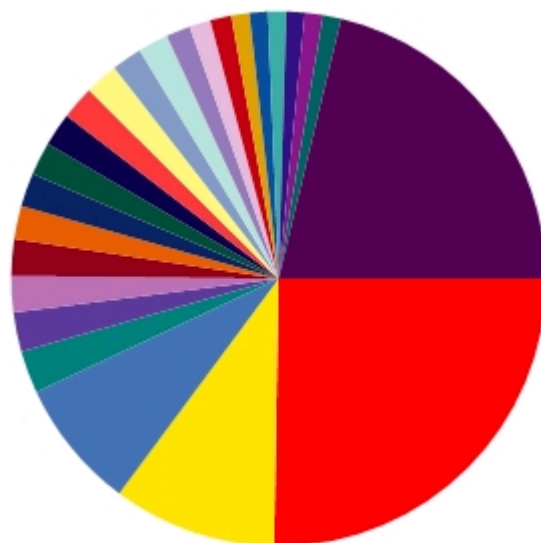

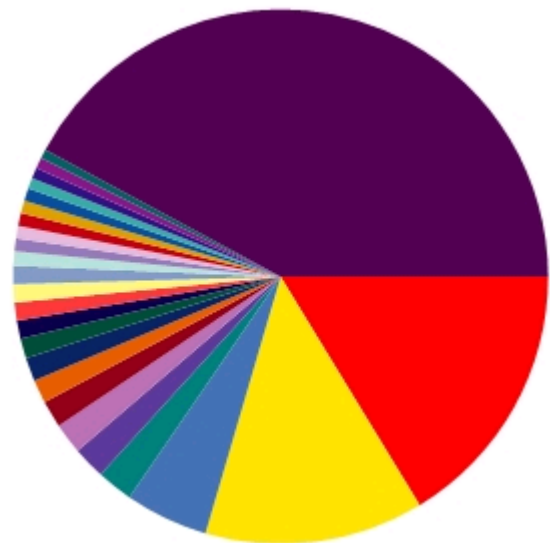
