

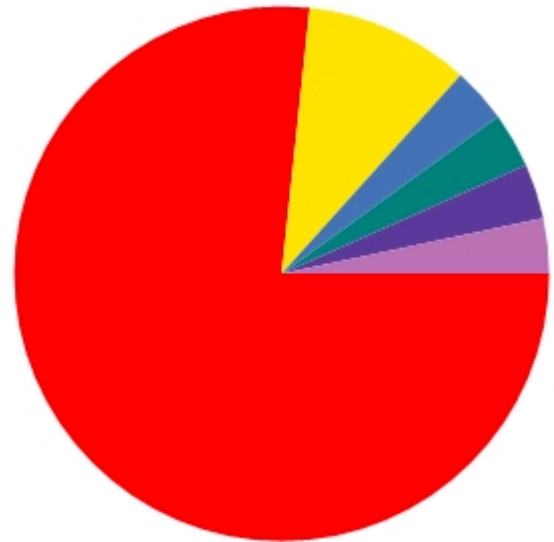

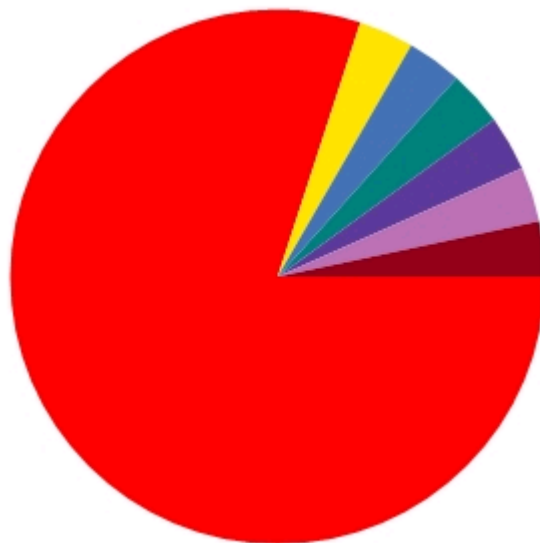

Case Count by Jurisdiction

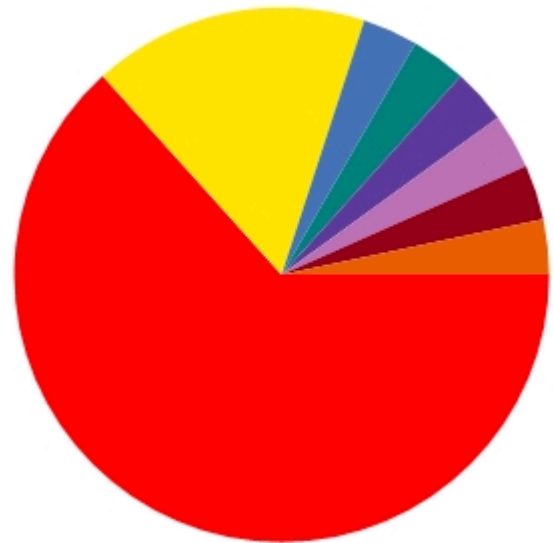

Case Count by Court

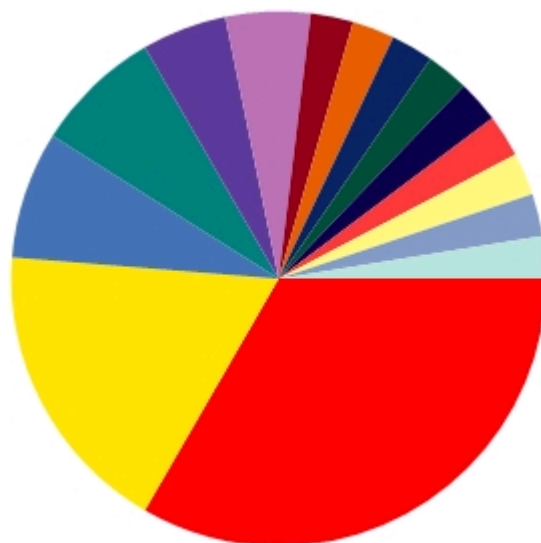
