### Article Icon in Search Results



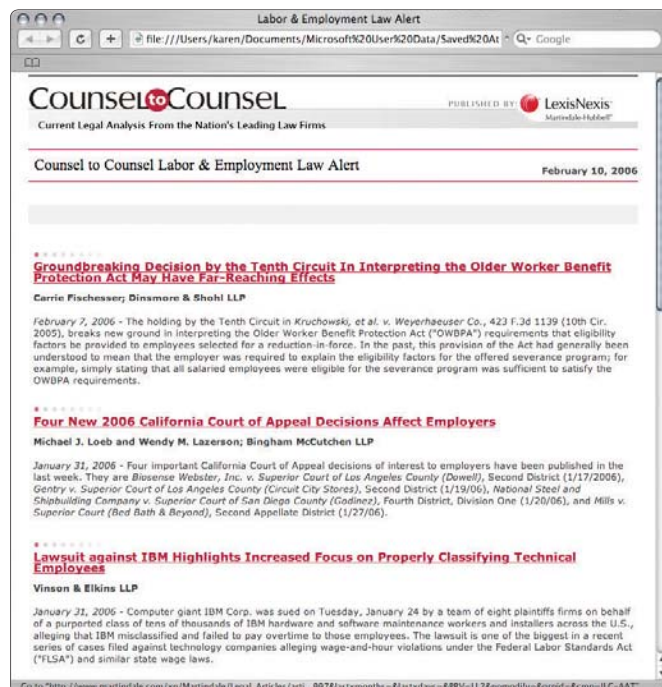
