Federal and State Opinions	Case opinions can help you find challenges, successful or not, to an expert's testimony.	Cases	✓

Verdict Reports	Verdict reports usually indicate which experts have worked on particular lawsuits, so use them to evaluate potential biases (e.g., does he/she repeatedly testify for the same attorney/firm or the same side?). Moreover, because these reports usually include the case name, case number, jurisdiction and the attorneys involved, use them to find additional information about experts (e.g., reports, transcripts, etc.). Statements, Transcripts and Reports	Better understand an expert's attitude, approach and even prior contradictory statements through access to prior testimony transcripts, affidavits/declarations and reports. Law Review Articles	Though seemingly an unlikely source of information about experts, law review articles often mention experts, their publications or their testimony (or challenges to it).	Secondary Materials	✓
Congressional Information	Prominent experts submit documents such as letters and reports to Congress and some actually testify before congressional committees. Track down what an expert actually submitted and/or said.	Statutes and Legislation	✓
Technical Journal Articles	Do not rely on article and publication listings provided by experts. Uncover omissions or inaccuracies by searching Elsevier® scientific journals, MEDLINE® References and more.	Scientific	Coming soon
Patent Applications	Gain valuable information from the patent applications of experts who are also patent holders.	Coming soon	Coming soon
