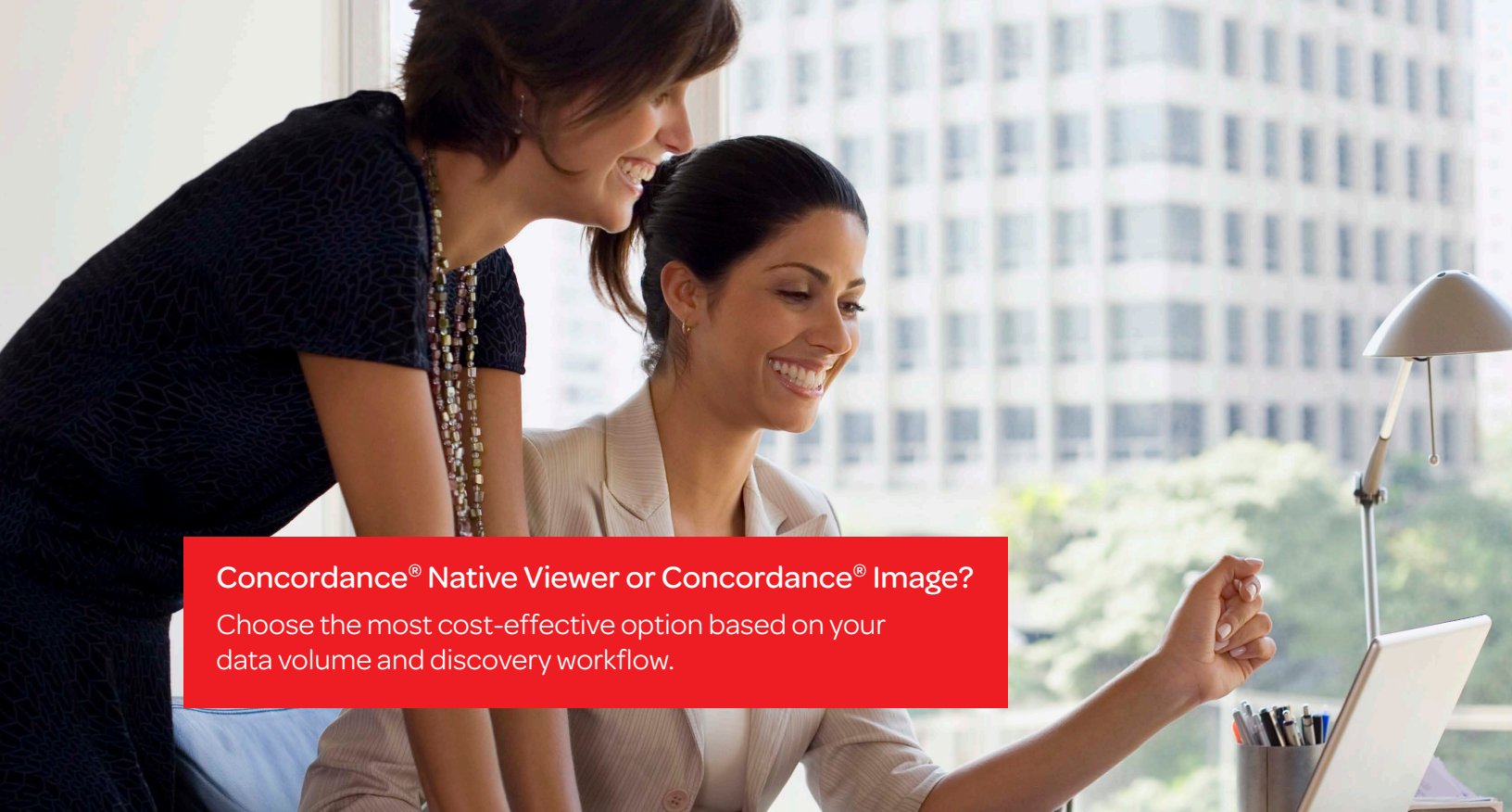

Do you automatically generate tagged image file format (TIFF) images as part of your normal discovery workflow? If so, Concordance Image can likely meet the majority of your needs.

However to help you keep costs lower, we will be pricing Concordance Native Viewer network licenses at a 3:1 ratio.

*If you wish to finish existing cases with single page TIFFs and move towards Natives and Multi Page TIFFs, you will need both Concordance Native View and Concordance Image.
