- Use of header/footer option
- · Use of watermark option

OCR

Required to:

- Flag documents for OCR during any function but scan
- · Batch process OCR
- Single document OCR

E-Print

Required to:

 Batch process the printing of native files to paper

Print

Required to:

- Batch print TIFF files
- Apply header/footer as overlay (does not get applied to actual image)

Full-Text Indexing

Required to:

Build dictionary for key word searches

Admin

Required to:

- · Create new cases
- Perform functions listed under File-Administration
- · Create index fields
- Import raw images, load files and LAW PreDiscovery cases
- · Export all load files
- Duplicate detection

May be used to perform these functions, but is not required:

- Number documents
- Filter and search
- Access the database grid
- · Create and edit folders
- Set preferences

Searchable PDF (add on)

Resides with the OCR license

Required to create searchable PDF files
