Redact Securely—Without Altering Originals

- All redacted information is marked privileged and covered completely—all underlying, electronic layers, not just the surface layer like some PDF options.
- **Move from search results into documents** to review specific text as needed.
- Review and de-select information. When ready, **redact appropriate information in one step.**
- **Insert annotations** or comments.
- Your organization's approved personnel can still **see what was redacted.**

Then Send, Save and Monitor Requests

Concordance software offers document **production, processing and record-keeping capabilities.**

For example:

- After collecting and redacting documents, **batch print, download or e-mail**
- **Save redacted document collections** for future requests, greatly reducing photocopying, searching and redacting time and expense
