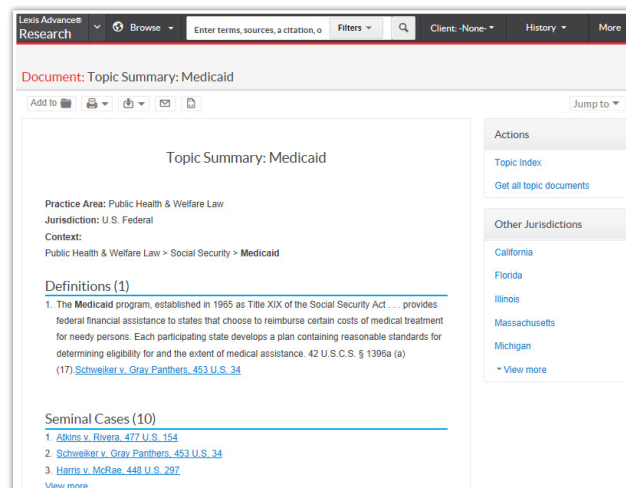

Consult more archived editions for deep research Constitutions

Archives for the U.S. Constitution as well as all 50 state constitutions (plus the constitution of Puerto Rico) are now available. Constitutions are TOC (Table of Contents) sources. When you view full-text constitution sections, you can link to all available archive section versions.

Code of Federal Regulations and Administrative Codes

Get archive coverage for the District of Columbia and all 50 states' administrative codes. (Coverage varies by jurisdiction.) CFR coverage dates back to 1993. Tap into insights from these resources the same way as constitutions and codes. Search the current-version source or select the TOC link. You can browse or search the full TOC—or just search the title, chapters and/or parts you need. The About This Document box on full-text CFR and administrative code documents **will include links to archived section** versions.

Just select your topic and review all 50 states' and the District of Columbia's positions on the topic—complete with links to the current controlling statutes.

You can add this source to a Lexis Advance search. Or select the TOC link and get access to more than **200 enhanced charts divided into seven major categories**: Administration & Procedure; Personal Income Tax; Corporate Income Tax; Property Tax Estate; Inheritance & Gift Taxes; Sales & Use Taxes; and Miscellaneous Taxes. Expand a category to view and select topics.

Each downloadable PDF chart examines a narrow issue or aspect of state taxation for each of the states and the District of Columbia. For each of the 51 jurisdictions, you get a summary explanation of the state's position on the issue and a **link to the controlling statute**. Plus chart summaries offer helpful background information about the tax issue.

[Consult World Court filings and judgments plus international treaties and agreements](#)

The International Court of Justice, also known as the World Court, has a dual role: to settle legal disputes submitted by its member states of the United Nations (currently 191) in accordance with international law, and to give advisory opinions on legal questions referred to it by duly authorized international organizations and agencies.

International Court of Justice Filings (from 2004) offers full-text, English-language interim documents filed with the International Court of Justice for pending cases, including the application and written pleadings, as well as various orders of the court, where available.

International Court of Justice Judgments (from 1948) gives you access to full-text, English-language judgments of the court, covering cases between the member states.

International Legal Materials from the American Society of International Law (ASIL) Find the basic, primary documents you need for analyzing international law. These documents are selected by ASIL for their usefulness to scholars, practitioners, and business and government officials from the United States and abroad. Review the full text of:

- important treaties and agreements
- judicial and arbitral decisions
- national legislation
- resolutions from international organizations
- and other documents

Examples include the Vienna Convention of Law on Treaties; UN Convention of the Law of the Sea; International Covenant on Economic, Social and Cultural Rights; European Union/European Communities treaties and conventions; Free Trade Agreements from around the world; and selected European Court of Human Rights, UN, World Bank, WTO and WTO materials.
