You can also pre-filter your search to look in Topic Summaries only. Enter *Topic Summaries* in the Red Search Box and select this filter.

You can still browse and link to Topic summaries as well. You can gain access from full-text documents and from the Browse Topics hierarchy. Just look for the Briefcase icon or the Topic Summary list in the About This Document box.

Topic Summary Reports are valuable overviews and authority finders, compiling links to seminal cases and controlling statutes on your topic, defining burden of proof and standards of review, and offering additional definitions, secondary sources and even links to specific state authority on the topic.

See the big picture before taking a deeper dive. Case search results now display the case overview above your search term hits so you can better determine whether the entire case might be worth exploring further.
