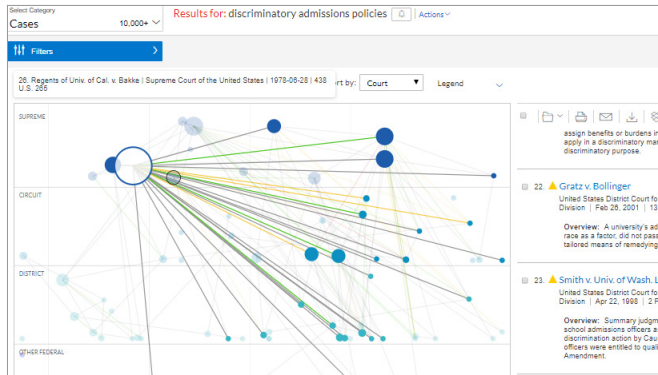

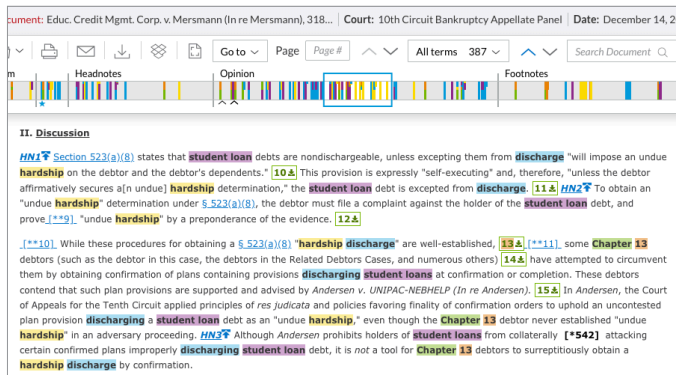

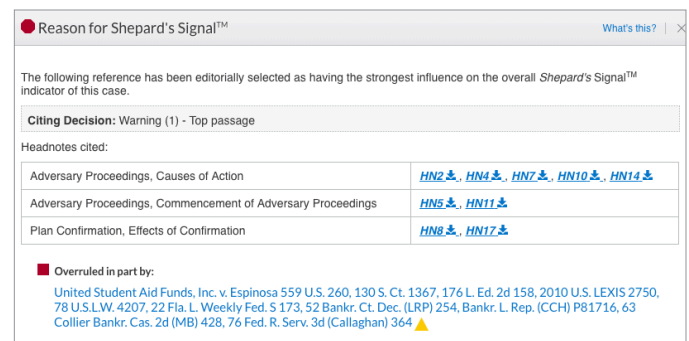

³600 random case searches were tested April and May 2019. Searches covered a variety of topics. Each search was entered in the Westlaw home page search box. A jurisdiction pre-filter was applied. Various federal and state jurisdiction pre-filters were used. After recording the results, the same search was entered and the same filter was applied post search. Results were recorded. Of the 600 searches, 483 (80.5%) produced different results numbers when pre-filter and post-filter results were compared. Of the 483, 48 post-filtered searches (nearly 10%) missed 100% of pre-filtered results.
