

LexisNexis Travel Reimbursement Guidelines For Contractors, Consultants and Service Providers 2004

<u>Airfare</u>

LexisNexis will reimburse for Super Saver, Tourist and Coach class airfare. LexisNexis will <u>not</u> reimburse for First Class or Business Fare. Airfare may be booked through World Travel Partners (WTP). Your LexisNexis contact can put you in touch with the LexisNexis travel office. Preferred airlines include: American Airlines, British Airways, Continental Airlines, Delta Airlines, America West Airlines, Northwest Airlines/KLM-Royal Dutch Airlines, US Airways, Frontier and American Trans Air.

Personal Auto

Mileage directly associated with the subcontracted work will be reimbursed at the current IRS published mileage reimbursement rate. Mileage reimbursement does not apply to Contractors working as supplemental staffing to LexisNexis.

Taxi cabs, Parking, etc.

Taxi, bus, rapid transit, airport limousine, tolls and parking charges are reimbursable if directly associated with the subcontracted work. Airport or long-term parking at an airport is reimbursable with an original receipt. Hourly airport parking will only be reimbursed if it is for the purpose of drop-off or pickup of the individual traveling to LexisNexis and it averts the need for long-term parking.

Per Diems:

LexisNexis will reimburse subcontractor based on actual expenses incurred up to the maximum per diem rates listed below for Lodging, Meals and Rental Car.

- All original receipts (no photocopies) must accompany all expense reports submitted with invoicing. Invoice payment will be delayed until original receipts are submitted.
- These guidelines may not be applicable to offshore or non-domestic travel, where the per diems are negotiated and outlined within the contractual agreement.
