# Research Map



With **Research Map** you get a step-by-step graphical depiction of your prior research history so you can quickly pick up where you left off. By clicking on the **Compare Search Results** tab, you can compare results from two to three different searches. You can then see if there are

any commonalities between the two searches. If there aren't, you can move forward with confidence knowing you've uncovered the most relevant documents for your case.




