

**Terms and Conditions of Create+ Survey Prize Draw**  
**(Terms and Conditions)**

<b>1. Entry Terms</b>	<p>1.1. Information on how to enter the Create+ Survey Prize Draw (<b>Prize Draw</b>) and prizes form part of these Terms and Conditions. To the extent of any inconsistency between these Terms and Conditions and any other published materials, these Terms and Conditions will prevail. <b>3. Nature of Prize Draw</b>	<p>3.1. This Prize Draw is a game of chance.</p>
<b>4. Eligibility</b>	<p>4.1. This Prize Draw is open to residents of Australia or New Zealand only aged 18 or over. (<b>Entrants</b>). <b>6. How to Enter</b>	<p>6.1. To enter and be eligible to win a Prize, Entrants must, during the Prize Draw Period:</p> <ul style="list-style-type: none"> <li>(a) access the survey available via the Survey Invitation (<b>Survey</b>);</li> <li>(b) follow the prompts on the Survey to register their details (including full name, email address, phone number and street address) as well as provide all the requested information;</li> <li>(c) complete the survey on the Survey; and</li> <li>(d) submit their response to the Survey so that it is received no later than the Closing Date.</li> </ul> <p>6.2. The Promoter will accept only one entry per person.</p> <p>6.3. 	(Cth) or similar consumer protection laws in the State and Territories of Australia or in New Zealand <b>(Non-Excludable Guarantees)</b> .
<b>14. Exclusion of Liability</b>	<p>14.1. Except for any liability that cannot be excluded by law, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of or in relation to this Prize Draw.</p> <p>14.2. Except for any liability that cannot be excluded by law, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible, and excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of or in relation to: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the Promoter's reasonable control; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by an Entrant or Winner; or (f) use of a Prize.</p>

Without limiting any other term in these Terms and Conditions, Entrant agrees to indemnify and keep indemnified the Promoter for any breach of the terms above.</p>
<b>16. Privacy</b>	<p>16.1. The Promoter collects personal information in order to conduct this Prize Draw and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to regulatory authorities. <b>17. Name and Likeness</b>	<p>17.1. Entrants consent to the Promoter using their name, likeness, image and voice (including photograph, film and recording of the same) in any media worldwide for an unlimited period without remuneration for the purpose of promoting this Prize Draw (including any outcome), and promoting any products or services supplied by the Promoter.</p>
