



Data-driven legal analysis

Lexis Web Service APIs toolkit provides an interface that allows you to make direct requests to the LexisNexis data services, bypassing the Lexis Advance web application entirely. The interface will allow your teams to work seamlessly across the entire spectrum of their workflow.



WORKFLOW

Build customised workflows within practice area pages by adding a search bar to find relevant information from Lexis Advance
