Penalty Unit updates

In 2021, there will be an increase to the penalty units for some of the Australian states and territories.

Any obligations whose consequences references are impacted will be updated.

Each updated obligation will have the following in the Historical Note field:

“dd/mm/yyyy - This obligation has been updated to account for increased penalty unit values taking effect from TBA Date. Organisations should review the Consequences section to confirm the latest applicable financial penalties. No other changes to the obligation have been made. For more information, refer to news alert xxxxxxxx.”

*** The highlighted sections will be substituted with the actual applicable date and the News Alert ID.**

At the completion of the update exercise a single News Alert will be published and attached the Overview Obligation for each Sub Module (Topic).

Changes to WA Government site
