


Solution & Outcomes

One of the features that was most useful to Briony was Lexis Argument Analyser, an Al-powered case law research tool. "On Lexis Advance, you can see that a case has referenced another case, but you can't see in what context it's been referenced. You have to read the whole case to work that out, and it takes a lot longer. With Argument Analyser, you can see that the cases are linked on the basis of the same topic. You can really limit the number of cases you have to read and the amount of reading you have to do in order to find the answers you're looking for."



Briony's experience with Lexis+ was one of renewed efficiency. "The user interface is a lot simpler, providing easier access to the sources you need, without having to deal with information overload," she says. "It made a big difference in terms of time, efficiency, and effectiveness. And the research was more detailed and in-depth than it would have been had I just trawled through the cases the way I would traditionally have done. Overall, I'd definitely recommend Lexis+."






