Background

Challenge

Wotton + Kearney had been monitoring the progress of generative AI to identify solutions that could enhance both client services and internal efficiency. The firm recognised that generative AI could significantly streamline work processes, especially in labor-intensive tasks like legal research, document review, and drafting. One of the main challenges faced by the firm was the time-consuming nature of legal research.

Lawyers often had to dedicate considerable effort to finding case law relevant to a matter. Traditional research methods relied heavily on identifying precise keywords, which meant lawyers either had to generate numerous Boolean searches or conduct broad searches, reviewing extensive results to find the most relevant cases.

Additionally, determining whether to pursue ancillary issues in a matter posed another challenge. Every sub-issue incurs further costs for the client. Lawyers had to carefully weigh the value of additional research versus the cost, often limiting the exploration of potential issues.

Wotton + Kearney sought a generative AI solution that could reduce the time and effort required for these tasks, without compromising the quality of the legal work. The firm involved key stakeholders including partners, IT teams, and legal staff throughout the decision-making process, ensuring that the solution implemented aligned with the strategic goals and needs of the firm.

Solution
