Note:

- All Microsoft SQL Server Express editions have a database size limit of 10GB. SQL Server Express 2008 to 2014 or earlier are no longer supported. Once the client's Lexis Convey database reaches the database size limit on SQL Server Express the onus remains on the client to upgrade their version of Microsoft SQL Server to a requisite level for their infrastructure.
- Ensure that you have the latest service packs installed before contacting the Lexis Convey Support Team as only the latest service packs are supported for all operating systems & SQL Server. Windows Server 2019 or earlier are no longer supported.
- SQL Server can dynamically allocate the optimal amount of memory (or cache) to the database
 to increase performance. Consider purchasing more than the required RAM to allow for a larger
 cache. Memory should be increased depending on the number of users connecting to the
 server and versions of Windows software used (see the Microsoft website for recommended
 specifications for Windows products).
- Free disk space recommendations only apply to run the software and do not include stored data.
- These specs are for a database and/or file server only. Please contact LexisNexis for a recommendation on minimum Terminal Server specs for your environment.

- Microsoft .NET Framework 4.8 or later must be installed. Earlier frameworks are no longer supported.
- Microsoft Word 2010 or higher is recommended and earlier versions are no longer supported.
- Microsoft Outlook 2010 or higher (optional). An email editor is built into the software. However, if Outlook is installed, the application can use it to send email (instead of SMTP). Earlier versions are no longer supported.
- Adobe PDF Reader is required to view online documents and reports.
- Attorney Gateway is required to send and receive electronic instructions and to access certain secure online web services.
- Display settings recommendation is 1024 x 768 resolution or higher,
- Microsoft Edge is a pre-requisite, and performance is subject to the user's internet bandwidth, the following bandwidth is recommended.
