1. Login

Go to <http://www.mlex.com/User/Welcome.aspx> and sign in. If you are redirected to mlexmarketinsight.com, click on the Subscriber Login button in the top right-hand corner. Enter your login credentials and tick the “Remember” box. You will need to accept the Terms & Conditions.

If you forget your password please use password reset on the Login page – click on “Forgot Password?” You will be directed to the Forgot Password page and prompted to input your email address (username). A link to reset your password will be emailed to you.

Changing Your Password

Clicking on the “[First Name]’s Mlex button in the top right-hand corner of any page and selecting “Profile” from the drop-down list will show you your current details and also allow you to change your password. For security reasons, we recommend you change your password when you first log in.

Remember to click “Save” to confirm any changes.



2. Navigating Your News Page

Depending on your subscription, the content on your front page may look different to the example provided below.

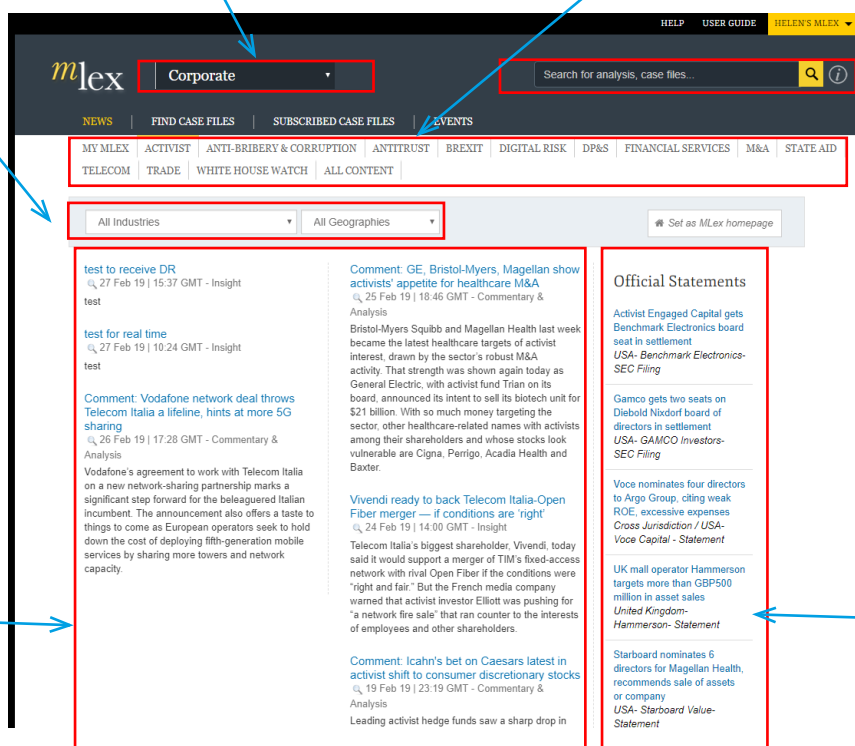
Product – If you have access to more than one MLex product, please use the drop-down menu to switch between products.

If you have access to more than one module use the tabs to move between them. If you subscribe to more than one module you can click “All Content” to get a single view of your modules.

User the drop-down menus to filter the coverage

Search - Enter a key-word(s) to search across the content in your selected product. You will be able to filter to refine your results on the search results page.

Articles appear in order of publication – the most recent will be at the top. See below for an explanation of the different content types.

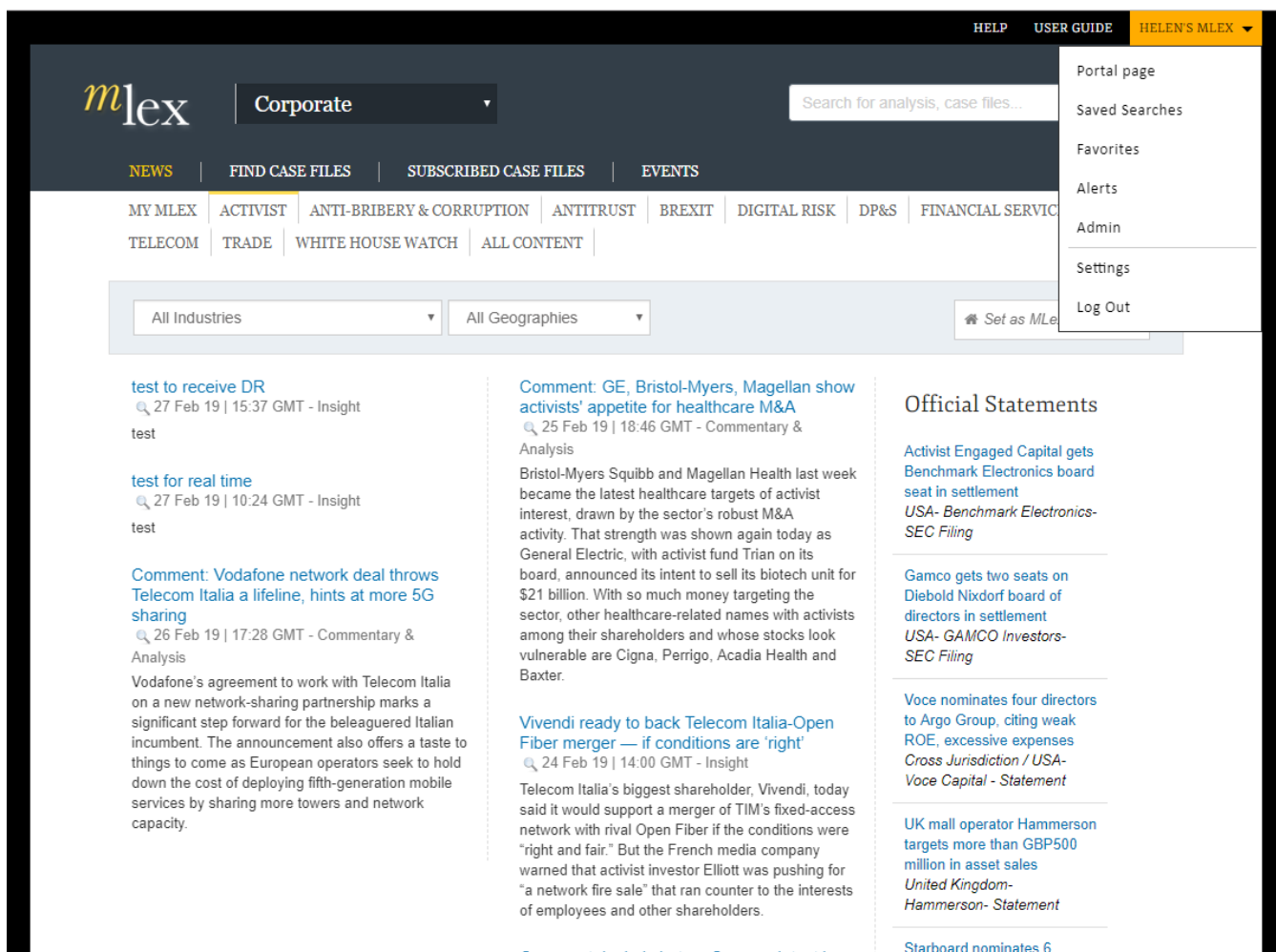

Official Statements: External documents relevant to cases and legislation MLex is following. These include court documents, press releases, official reports, legal authority decisions and legislative process documents.



Click on the “[First name]’s MLex button in the top right-hand corner to access a drop-down menu to:

- **Portal Page** – this will only appear in the drop-down if you have access to more than one product.
- **Dashboards** – this feature enables you to access and share content with colleagues. Dashboards are created using keywords. See page 11 for more information on dashboards. Please note: Dashboards are only available as part of an Enterprise subscription.
- **Saved Searches** – this enables a user to save a keyword(s) search for future use. Email Alerts can also be created using the Saved Search feature.
- **Favorites** – add a story or a Case File to your Favorites for quick access to it.
- **Alerts** – this is where you set your email alert preferences
- **Settings** – amend your personal details, and change your password.

3. Setting up email alerts

You can customize your Mlex subscription to send you an alert every time content relevant to your work or interests is published. These alerts are sent to the email address associated with your account.

There are different types of alerts

- i. **Real-time Alert** - An alert is sent to you as soon as a new story is published. See below for information on how to set up Real-time Alerts.
- ii. **Daily Alerts** - A round-up alert of all the new stories published in a day, emailed to you at 6.30pm in your selected time zone.
- iii. **Saved Search Alerts – Keyword Alert:** You can also create a customized alert based on a keyword. Every time your keyword appears in a story Mlex has written or an Official Statement, you will be sent an alert.
- iv. **I'm getting too many email alerts** – if you find you're receiving too many email alerts, you can adjust these in the alerts management section or unsubscribe to stop receiving all.

Alerts Management

This page will help you set up alerts at a basic level, based on your interested areas. If you wish to refine this to a more granular level then we'd suggest using the saved search feature to do a keyword search and filtering on this.

To find alerts go to "[First Name]'s MLex" and select "Alerts" from the drop-down menu. You will be directed to the Alerts set-up page (below)

Configure your alert settings and remember to save.

Please note that if you click the "Unsubscribe" button you will be unsubscribed from all MLex email alerts. You won't be able to edit your preferences once the button is pressed, but you can return to your original settings by clicking the button.

ii. Daily Alerts

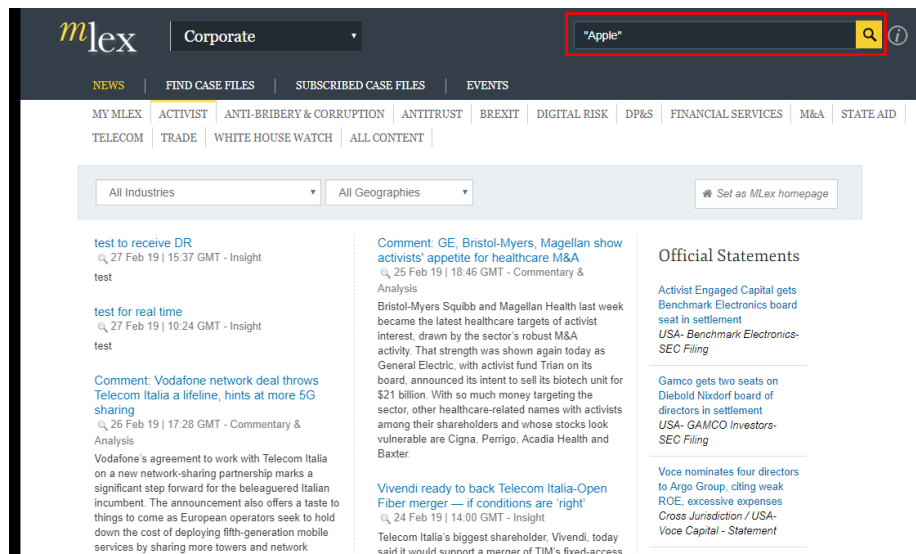

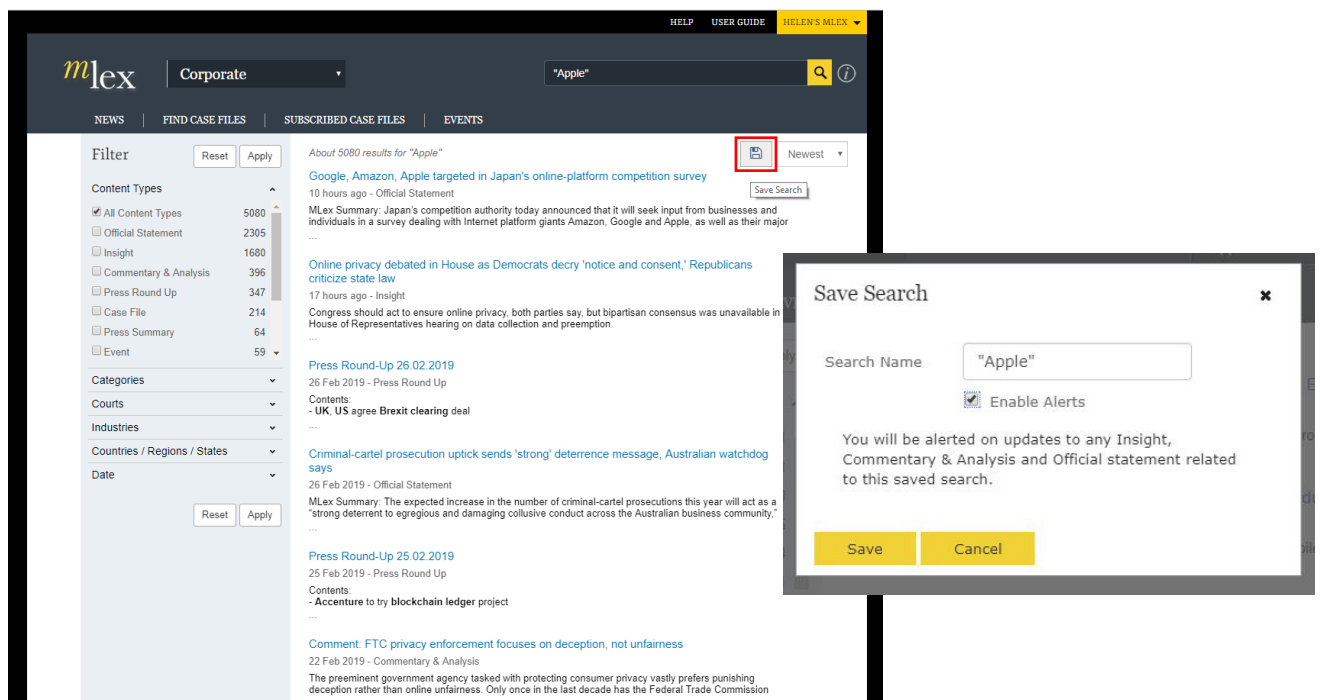
iii. Saved Search Alerts

You can also create alerts based on saved searches. Type a keyword into the Search box and search. You will be taken to the Search Results Page.



From here you can refine your search using the Filters on the left.

When you are ready to save your search click on the Save icon. A pop-up box will appear – from here you can save your keyword as a Saved Search and Enable an alert.





iii. Saved Search Alerts

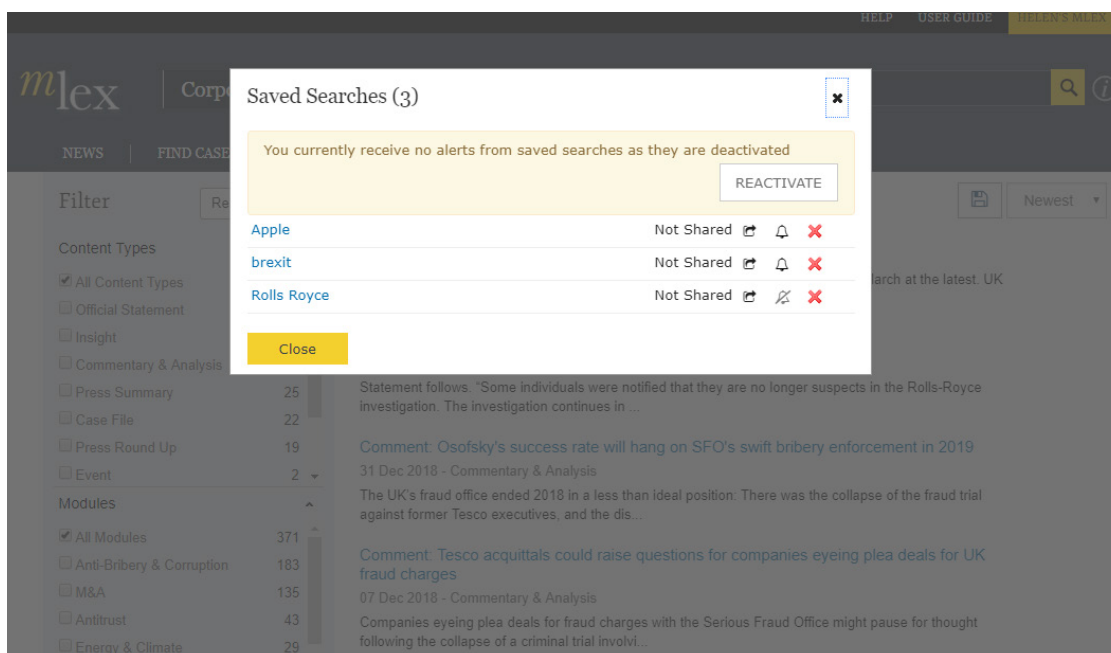

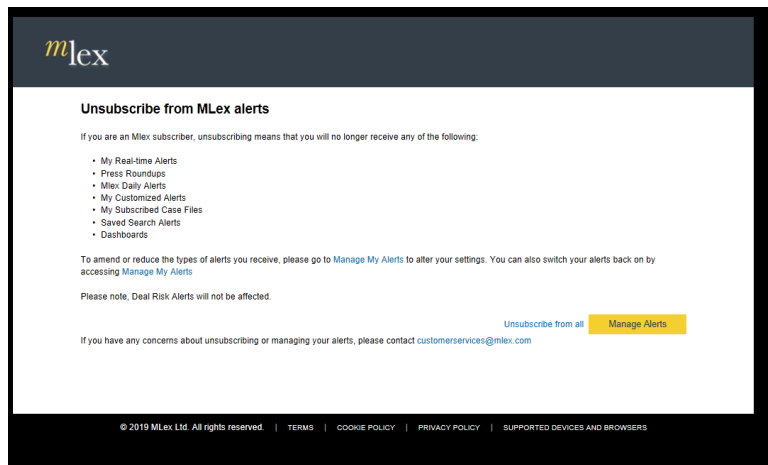

4. Searching for content

As well as reading new stories as they are published, your Mlex subscription allows you to search through more than 10 years of insights, commentary and analysis.

To start a new search simply enter a search terms or keyword in the search box and click the search icon.

Refine your search by using the filters. Depending on your subscription, there may be search filter options for Content Type, Categories, Courts, Industries, Geographies. You can also filter using a date range.

This is also an excellent way to search for Case Files – after searching on your keyword, tick Case File on the Content Types filter.

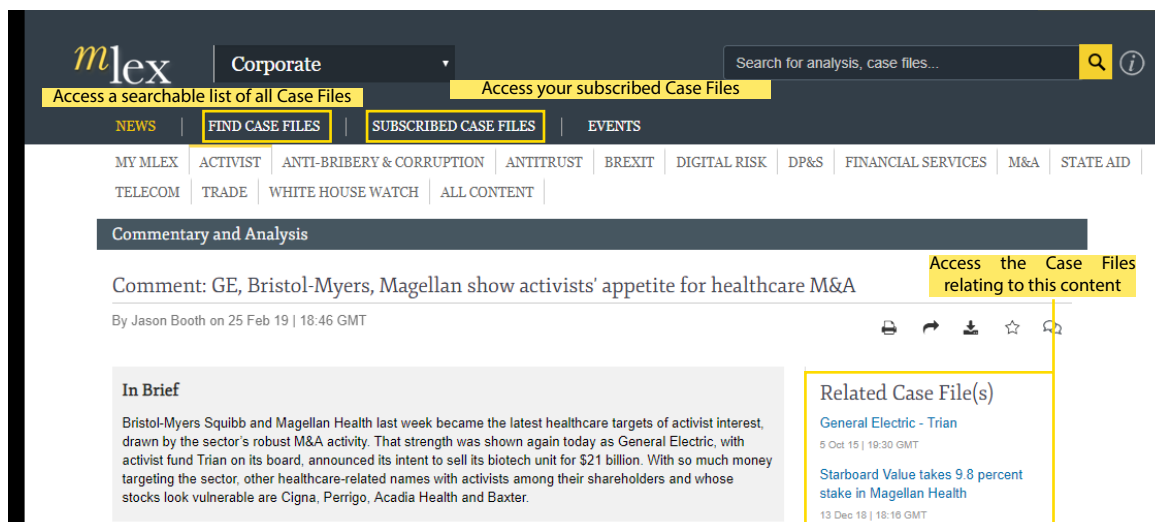

5. Using Case Files

Content published on MLex is organized into Case Files. Each Case File includes a mix of our proprietary insights, commentary and analysis, key dates and official statements.

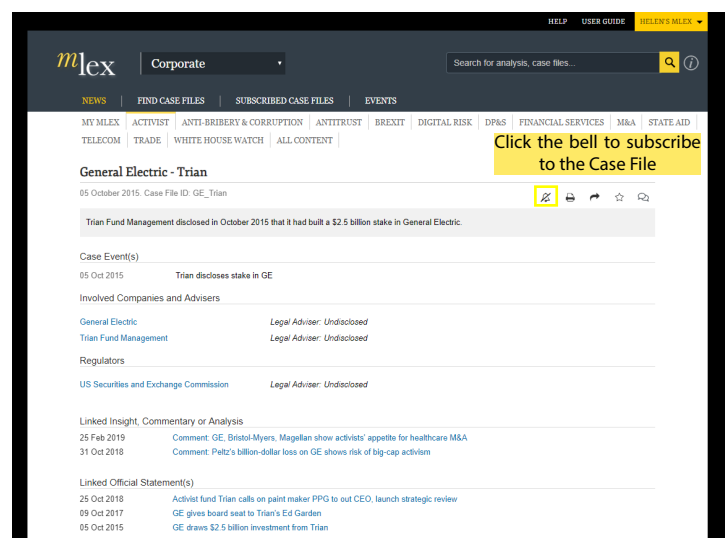
You can access relevant Case Files from any content through the “Related Case Files” section next to the In Brief Summary. You can also access a searchable database of all Case Files from the “Find Case Files” link in the top menu and choose to receive alerts on the Case Files you subscribe to.



On the Case File page you’ll find:

- a summary of the case
- a list of key dates
- relevant companies, advisors and regulators
- a list of relevant proprietary content
- a list of linked official statements
- A bell icon that allows you to subscribe to the Case File and receive alerts

The Dashboard feature enables you to access and share relevant Mlex content quickly and easily.

1. Dashboard Name
2. Content Categories – Each dashboard organizes the relevant content into four different categories - Insight/Commentary, Official Statements, Press Summaries, Case Files.
3. Refresh – Click to ensure you are viewing the latest content.
4. Share – Click to share your Dashboard with colleagues you specify.
5. About – Click to access information about the shared dashboard – who created it, when it was created, who shared it with you and when they shared it.
6. Delete - Click to delete this Dashboard. NB This will only delete the Dashboard from your Dashboard homepage. It will not delete Dashboards you have shared with colleagues.
7. Alert – the bell icon indicates whether an alert has been set for this dashboard.



ii. How to Create a Dashboard

Search for a specific keyword or phrase.
On the Search Results page, refine your search using the filter options on the left-hand side.

iii. How to Share a Dashboard

To share a Dashboard, open the Dashboard and click on the Share icon 

A pop-up box will appear – Click in the Choose Contacts area and either select from the list or type the first part of a name or email address. Once your list is complete you can select whether to set up alerts for the colleagues you are sharing the dashboard with.

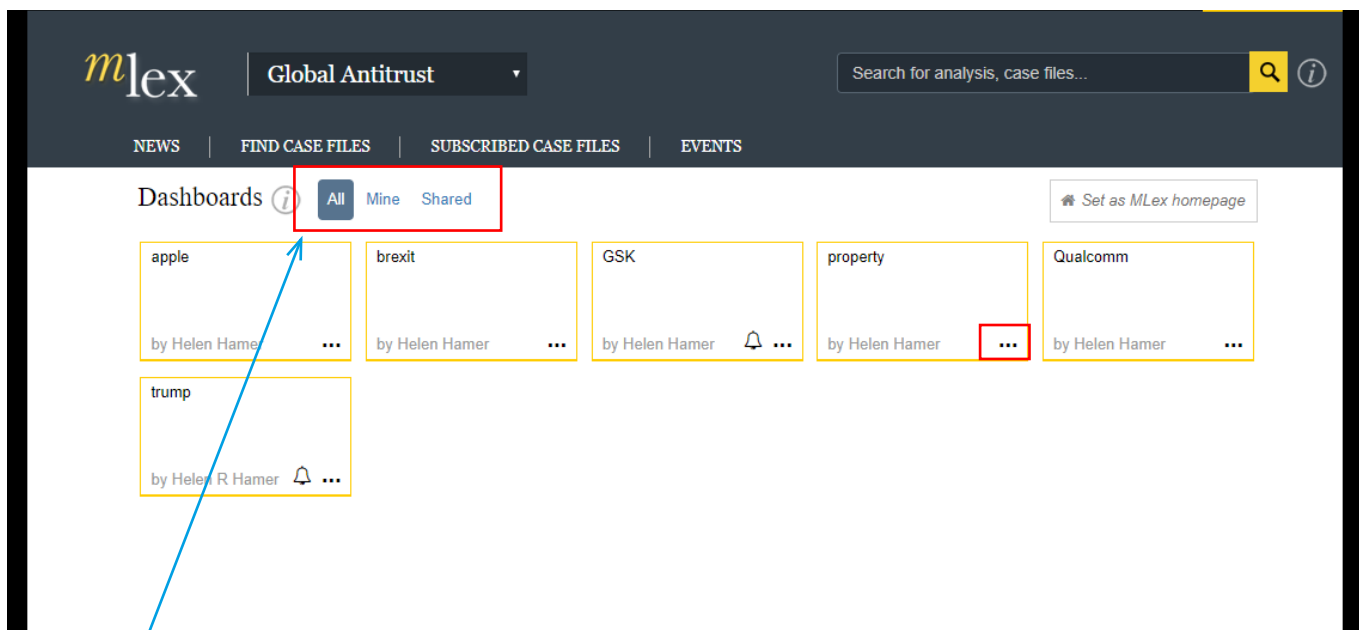
Select Share when you are finished. An email will be sent to all the addresses you select informing the recipients that you have shared a Dashboard with them.

iv. How to Access your Dashboards

To access and manage your Dashboards, Click on “[First Name]’s MLex in the top right-hand corner and select Dashboards from the drop-down menu.

Your Dashboards homepage will appear. This page lists your Dashboards in alphabetical order. Click on a dashboard to open it.

Activate and De-activate your Dashboard alerts using the bell icon.



All – All Dashboards – ones you have created and ones that have been shared with you.

Mine – Dashboards you have created

Shared – Dashboards that your colleagues have created and shared with you.



If you wish to switch your dashboards off for a particular product, you can make the section inactive. Your Dashboard settings won't be affected, so if you reactivate, the same settings for dashboards will resume.
