SCOPE AND CONTENT NOTE

On the streets of Brooklyn, New York, around 4:30 a.m. on December 8, 1985, Dionisio Hernandez got into a quarrel with his fiancée, Charlene Calloway, and her mother, Ada Saline. He shot his fiancée, and when her mother fled, Hernandez chased after her and tried to shoot her too. He missed, however, when she fell to the ground. The bullets went through the window of the Orocovis restaurant and injured two customers inside. Police arrested Hernandez on charges of attempted murder. In January 1987, Hernandez's case went to trial in the Supreme Court of Kings County. During voir dire (the preliminary examination to determine the competency of jurors), the prosecutor used his peremptory challenges to dismiss four Latinos from the jury. He dismissed two of the potential jurors because they had relatives with criminal records. He dismissed the other two potential jurors because Spanish was their first language and he was concerned that their language ability would "interfere with their processing of testimony delivered in Spanish" (Reel 13, Frame 0489). The judge accepted the prosecutor's argument and the case went to trial. The Kings County jury then convicted Hernandez. Hernandez appealed the decision, eventually making his way to the U.S. Supreme Court where he argued that the prosecutor's use of the peremptory challenges denied him his right to a fair jury trial.

The Hernandez case is one of fifteen cases reproduced in this edition of papers from the Legal Division Files of the Puerto Rican Legal Defense and Education Fund (PRLDEF) collection at Hunter College, City University of New York. The cases cover police brutality, searches and seizures, language use and ability, employment discrimination, jury selection, and the rights of homosexuals. Twelve of the cases come from New York City; one from Suffolk County, New York; one from Springfield, Massachusetts; and one from the Commonwealth of Puerto Rico. The files include correspondence, amicus curiae (friend of the court) briefs, transcripts of court proceedings, depositions, affidavits, and other court documents. The cases date from 1970 to 1992.

This edition contains five cases dealing with police brutality. The two largest of these cases are *Castillo v. Day* and *Cortes v. Conigliaro*. The first case involved Julio Castillo, who, on July 28, 1983, received a distress signal on his pager from his wife. His wife was in poor health and sometimes needed emergency medical attention. Upon receiving his wife's call, Castillo rushed home, allegedly racing through several red lights. Two New York City police officers spotted Castillo and gave chase. When Castillo stopped his car in front of his house, officer Edwin J. Day ordered Castillo to freeze. When Castillo continued towards the house, Day subdued Castillo with a kick to the groin. *Castillo v. Day* (Reel 5, Frame 0575 through Reel 7, Frame 0425) resulted from this confrontation.

The second case, *Cortes v. Conigliaro*, grew out of an incident at Joe's Pizzeria in Brooklyn. On January 23, 1981, New York City police officer Salvatore Conigliaro entered the pizzeria in search of three robbery suspects. He soon was involved in a fracas with Martha Iris Cortes and Jose Vasquez. Although Conigliaro claimed that

Cortes assaulted him, Cortes filed a complaint with the New York City Police Department's Civilian Complaint Review Board asking for monetary damages.

The other police brutality cases in this edition are *Carmona v. NYPD*, *Coleman v. Klein*, and *Rodriguez and Rivera v. Port Authority*. In *Carmona v. NYPD*, residents who lived near the Columbus Manor apartment building at 70 West 93rd Street complained that New York City police officers were harassing them when they tried to use the public space in front of the building. *Coleman v. Klein* was a class action case in which African American, Puerto Rican, and Hispanic residents of Suffolk County sued the Suffolk County Executive because they claimed they were singled out for "brutal and abusive treatment" by Suffolk County police officers (Reel 1, Frame 0841). *Rodriguez and Rivera v. Port Authority* resulted from an incident in the Port Authority of New York and New Jersey bus terminal.

Three cases in this edition relate to searches and seizures: *Perez v. Ward*, *People v. Alba*, and *Torres v. Commonwealth of Puerto Rico*. In *Perez v. Ward*, a confidential police informant accused New York City police officer John J. Perez of heroin use. Based on this information, Sergeant Edward J. Mahr ordered Perez to submit to a drug test. Perez refused. Perez's refusal to obey the order of a superior officer led to a hearing before Administrative Law Judge Nina Spiegler, who ruled that Perez had violated "a lawful and reasonable order" (Reel 4, Frame 0502). Based on this ruling, Police Commissioner Robert McGuire fired Perez from his position. Six months later, Perez sued seeking reconsideration of his case, reinstatement, and back wages.

The second case, *People v. Alba*, arose in the late 1970s when the Bronx Criminal Court was the target of several bomb threats. In response to these threats, court officials posted a large sign outside the courthouse informing all visitors that they might be subject to search. In March 1978, political activist Vicente Alba entered the Bronx Criminal Court to observe proceedings. Court security personnel identified Alba and decided to detain him. Alba refused to undergo a search but the officers frisked him anyway. The security officers found a gun in Alba's waistband and arrested him for illegal weapons possession. *People v. Alba* is one of several cases in this edition in which PRLDEF was joined by other prominent legal defense and civil rights organizations in defending a person's rights or submitting *amici curiae* briefs. In this case, PRLDEF submitted an *amici curiae* brief along with the New York Civil Liberties Union, Association of Legal Aid Attorneys of the City of New York, Legal Services Staff Association of New York City, National Lawyers Guild of New York City, National Conference of Black Lawyers, Asian American Legal Defense and Education Fund, National Alliance Against Racism and Political Repression, and the National Emergency Civil Liberties Committee (Reel 5, Frame 0195).

The third case on the topic of searches and seizures, *Torres v. Commonwealth of Puerto Rico* (Reel 5, Frames 0417–0567), involved questions of airport and border security. After Terry Torres arrived at Isla Verde International Airport from Miami, two officers from the Puerto Rico Police Department accosted Torres and asked to search his bags. They acted under a law that allowed them to search passengers and bags arriving from the United States. Upon searching Torres's belongings, they found a bag of marijuana and a pipe containing marijuana residues. The officers arrested Torres for violating the Controlled Substances Act. At trial, Torres argued that the search was unreasonable and a violation of both the Fourth Amendment to the U.S. Constitution and Section 10 of Article II of the Constitution of the Commonwealth of Puerto Rico.

In addition to police brutality and illegal searches, this edition covers cases pertaining to language use and ability: *Springfield Housing Department v. Olivo and Colon* and the *Hernandez* case discussed above. In *Springfield Housing Department v. Olivo and Colon*, the city of Springfield, Massachusetts, attempted to evict Olga Olivo and Lucy Colon and their children from their apartments after the city housing inspector condemned the units as “unsafe and unfit for human habitation” (Reel 3, Frame 0476). The city served Olivo and Colon with a notice to vacate in English, but both Olivo and Colon ignored the notice because of their limited English ability. They were convicted of refusing to comply with a written order. The major question in this case was whether a Spanish-speaking person unable to read English could be convicted of refusing to comply with a written order when that order was written only in English.

Five brief cases round out this edition. These cases cover employment discrimination, discrimination in jury selection, and the rights of homosexuals. In three related cases, *Gonzalez v. Lansky*, *Gonzalez v. Board of Examiners of the City of New York*, and *Gonzalez v. Board of Education of the City of New York*, Rafael Gonzalez argued that he had been discriminated against when the New York City Board of Education refused to hire him as a bilingual teacher assistant because of a conviction for possession and sale of narcotics when he was nineteen years old. *Cruz v. United States* pertains to jury selection and is related to the *Hernandez* case discussed above. The final case in this edition is *Under 21 v. City of New York*. In this case, the Under 21 organization, together with the Catholic Home Bureau for Dependent Children, Kennedy Child Study Center, Catholic Charities Counseling Service, and the Salvation Army challenged an executive order of the mayor of New York City that forbade discrimination in government contracts on the basis of “sexual orientation” and “affectional preference.” PRLDEF, along with the NAACP Legal Defense and Educational Fund, Inc., National Organization for Women, National Conference of Black Lawyers, Asian American Legal Defense and Education Fund, Center for Constitutional Rights, Lambda Legal Defense and Education Fund, New York Civil Liberties Union, and the New York County Democratic Committee, submitted an amici curiae brief supporting the mayor’s executive order.

This edition of records of the Puerto Rican Legal Defense and Education Fund represents the first section of Legal Division Files microfilmed by LexisNexis. Cases pertaining to employment, unemployment, and welfare can be found in *The Puerto Rican Legal Defense and Education Fund, Part 2: Legal Division Case Files, Section B*. Board of directors correspondence, meeting minutes, annual reports, financial statements, and other materials comprise *The Puerto Rican Legal Defense and Education Fund, Part 1: Executive and Administrative Records*.
