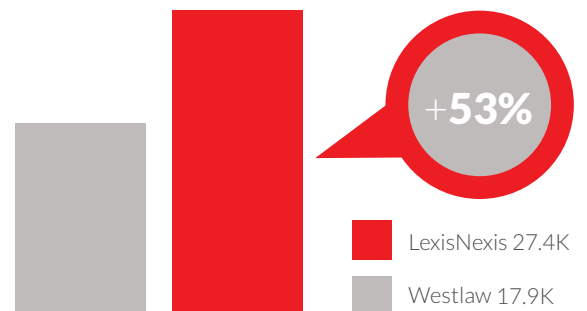

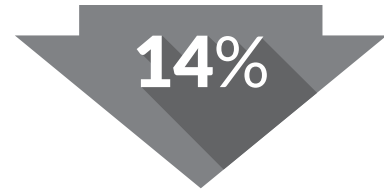

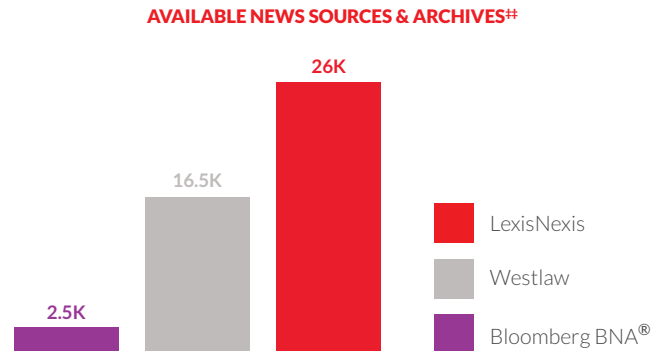


Decrease in Westlaw or WestlawNext usage between 2012 – 2015

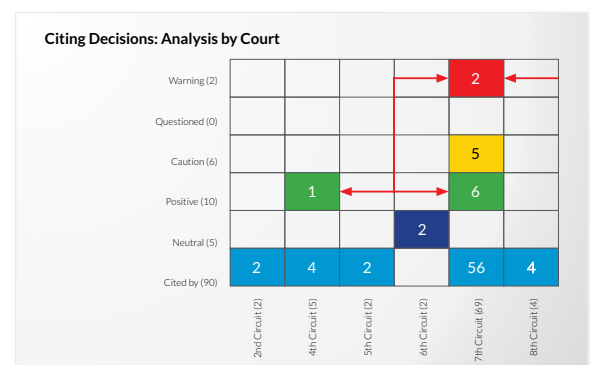
