OPINION AND ORDER GRANTING DEFENDANT'S PETITION FOR RECONSIDERATION (Appeals Board en banc)

Defendant seeks reconsideration of the December 22, 2015 en banc Opinion And Decision After Reconsideration (Decision) of the Appeals Board, wherein it was held that Chapter 20 of Division 8 of the Business and Professions Code (Chapter 20) by its own terms does not apply to a lien claimant seeking to recover copy service fees that are medical-legal expenses under Labor Code section 4620(a) when the lien claimant is an agent and/or independent contractor of a member of the State Bar at the time the documents are photocopied. It was further held in the Decision that when a lien claimant makes an unrebutted prima facie showing that it is an agent and/or independent contractor of a member of the State Bar at the time the documents are photocopied, proof of compliance with the registration and bonding provisions of Business and Professions Code sections 22450 and 22455 is not required.

Taking into account the statutory time constraints for acting on the petitions, and based upon our initial review of the record, we believe reconsideration must be granted to allow sufficient opportunity to further study the factual and legal issues in this case.¹ We believe that this action is necessary to give us a complete understanding of the record and to enable us to issue a just and reasoned decision.

Reconsideration is granted for this purpose and for such further proceedings as we may hereafter determine to be appropriate.

For the foregoing reasons,

IT IS ORDERED that defendant's petition for reconsideration of the December 22, 2015 en banc Opinion And Decision After Reconsideration of the Workers' Compensation Appeals Board (en banc) is GRANTED.

7 **IT IS FURTHER ORDERED** that pending the issuance of a Decision After Reconsideration in 8 the above case, all further correspondence, objections, motions, requests and communications *relating to* 9 the petition shall be filed only with the Office of the Commissioners of the Workers' Compensation 10 Appeals Board at either its street address (455 Golden Gate Avenue, 9th Floor, San Francisco, CA 11 94102) or its Post Office Box address (P.O. Box 429459, San Francisco, CA 94142-9459), and shall not 12 be submitted to the district office from which the WCJ's decision issued or to any other district office of 13 the Workers' Compensation Appeals Board, and shall not be e-filed in the Electronic Adjudication 14 Management System (EAMS). Any documents relating to the petitions for reconsideration lodged in 15 violation of this order shall neither be accepted for filing nor deemed filed.

All trial level documents not related to the petitions for reconsideration shall continue to be e-filed through EAMS or, to the extent permitted by the Rules of the Administrative Director, filed in paper form. If, however, a proposed settlement is being filed, the petitioner should promptly notify the Appeals Board because a workers' compensation administrative law judge cannot act on a settlement
