The National Commission on State Workmen's Compensation Laws (NCSWCL) submitted its Report to Congress and to the President in July 1972. The National Commission, whose members were appointed by the Nixon Administration, described state workers' compensation laws as "in general neither adequate nor equitable;" made 84 recommendations for a modern workers' compensation program; designated 19 of the recommendations as essential; and recommended that Congress enact federal standards to guarantee compliance with the 19 essential recommendations if the states did not quickly improve their laws. The Report resulted in a "Reformation Period" that lasted almost a decade when most states significantly improved their laws to avoid the federal standards unanimously recommended by the National Commission.

The reform movement was at eventide during the 1980s, and then the "Counter Reformation Period" began in the early 1990s and continues until 2012 with no signs of ebbing. Workers' compensation benefits have been curtailed and compensability rules have been tightened in a distressing variety of ways.

What should be done to restore the vision of adequate and equitable state workers' compensation programs envisaged by the National Commission? And what can be done to restore that vision for workers' compensation at the federal and state levels? The WILG Symposium provides hard issues but promises no easy solutions.
