

W.Va. Tax Discriminated Against Fed. Retirees, Justices Say (2019 Law360 51-4)

The U.S. Supreme Court on Wednesday agreed with a federal retiree that West Virginia had discriminated against him under the doctrine of intergovernmental tax immunity by taxing his retirement benefits but not those of some similarly situated state employees.

Ex-KPMGer Admits Serial Tax And Bank Fraud, Cover-Up (2019 Law360 51-210)

An accountant who turned against his former colleagues at KPMG and the Public Company Accounting Oversight Board in a federal fraud case told a Manhattan jury Wednesday that he and his co-conspirators tried to cover up their crimes - and admitted that he also scammed the IRS and a lender for years without fully disclosing it to prosecutors until the eve of trial.

ABB Unit Settles Tax Dispute For About 10 Cents On Dollar (2019 Law360 51-101)

Electrical components maker Thomas & Betts Corp., a unit of Swiss multinational group ABB Group, has settled a \$13.3 million tax dispute with the Internal Revenue Service over transfer pricing for about \$1.6 million.

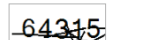
