### AI in Contracting

Artificial intelligence is moving from theory to practice in contract drafting and review. Expect disputes over authorship, liability and enforceability as machine-generated agreements start showing up in court.

### Digital and Smart Contracts

Blockchain-driven “smart contracts” and electronic transactions continue to grow. The challenge for 2026 will be how courts reconcile these with traditional contract principles and Uniform Commercial Code provisions.

### Evolving Force Majeure Clauses
