Creating a Permalink to a Company Dossier Snapshot

The Company Dossier Snapshot available through the Dossier search form on LexisNexis Academic provides business intelligence on more than 80 million global companies. The powerful Snapshot tool conducts multiple searches across key business and financial sources to bring together information on a company, its directors and executives, financials and stock price and contacts in an accessible, at-a-glance format.

Using the Permalink functionality available in LexisNexis Academic, create a link to a company's Snapshot using the company's Dossier ID. The Dossier ID is included in the company's Snapshot above their ticker symbol in the top left box (see screenshot below.)

Simply search for a company within Dossier and append the seven digit Dossier ID to this link: <u>http://w3.lexis.</u> <u>com/dossier/api/start.do?prod=CD&host=Rosetta_UK_</u> <u>News&LC=US&entityId=</u> As with all Permalinking on LexisNexis Academic, the user will have to access the link from within the school's IP range or from within the school's proxy server.
