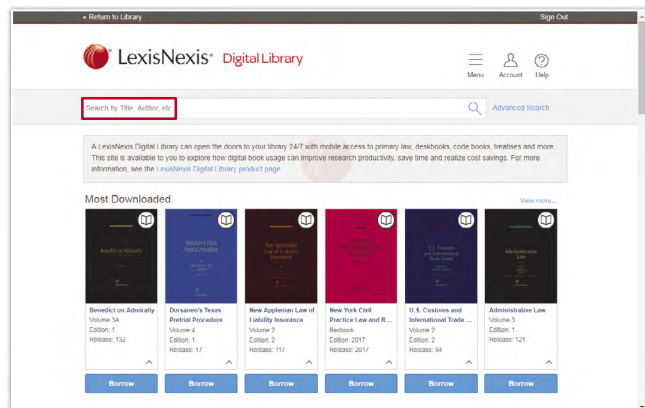

FIND THE EBOOK

1. Search the title, author or subject, or browse the content listing and select a publication.
2. If you do not know the name of the title, click the **Menu** function to display categories by practice area, jurisdiction and featured collections.

LEARN MORE ABOUT THE TITLE BEFORE YOU BORROW

More information about the title is available on the book details page when you click on the cover image or up arrow and click **More Info**.

Click the **Save to List** function to place the title in your bookshelf list and return later to borrow it. Use this feature to easily locate titles you use most often.

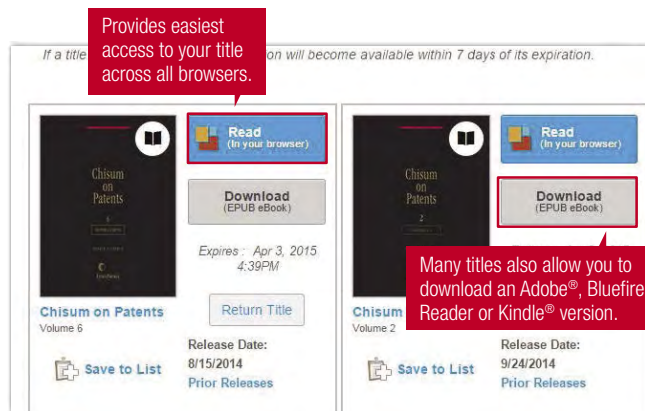
Click the **Share** feature to email a direct link of an eBook to another user within your LexisNexis Digital Library collection.
