

# Market Standards Coverage: Employment Agreements

The Market Standards - Employment Agreements database covers a wide selection of publicly filed new and restated U.S. executive employment agreements and employment letters, dating from 2017 to the present. One thousand agreements are selected for inclusion each year, including every agreement filed by issuers having a market cap exceeding \$10 billion and others selected to provide representation across issuer market cap level, position, industry, and governing law. The database currently includes over 5,200 employment agreements and 75 searchable data points as shown below.
