What's new in this release

The following features and enhancements are new in Time Matters 11.1.

Improved Exchange Synchronization

Microsoft® Exchange 2010 is now supported. Recurring Appointments in Outlook are now fully supported, with changes in either application being synchronized to the other. The setup and configuration process has also been streamlined, and you can import your configuration from previous versions.

Document Autonaming

The elements used to automatically create a document name now include Month, Year, and Class Code. Invalid characters are now automatically replaced with underscores (_).

Events in Time Matters Mobility

Event field mapping is available to support the addition of Events to Time Matters Mobility.

Obtaining the software

Time Matters 11.1 is available either via download or on CD. A download link appears in your product key email. To obtain a CD, call Sales at 800-328-2898.

Be sure to do the following before installing Time Matters 11.1:

- Perform a complete backup of your Time Matters data files and documents.
- Close Time Matters and all open applications on your computer.

3745138 Time entered in the Quantity field is retained if the Billing Item is set to "Do not bill" or "No charge".

Calendar/Scheduling

Addressed an issue with repeatedly opening and closing the same record on the Calendar.

Selecting Notify on an Event or ToDo with multiple Staff adds all the Staff to the To field.

Email

3820348 The Message field of Email forms consistently wraps Signature text when Word Wrap is enabled.

Exchange Sync

When individual occurrences of recurring Appointments are deleted from Microsoft® Exchange, the deletion is correctly synchronized with Time Matters.

Addressed an issue in which conflict resolution used Microsoft® Exchange data regardless of settings.

When converting from Exchange Synchronization 1.0 to 2.0, Body fields previously mapped to custom fields are correctly re-mapped to the Memo field.

3594728 Microsoft® Exchange appointments that recur on the "Last <day>" of each month synchronize correctly with Time Matters.

3136755 Improved the handling of invalid filters entered in the Exchange Synchronization Configuration tool.

Addressed an issue with synchronization after deleting Contacts in Exchange and then updating them in Time Matters.

Feature Packages

When creating a Formattable Clipboard template, all fields from Form Styles imported with a Feature Package can be linked.

Formattable Clipboard

3798139 When a Formattable Clipboard template prompts you to select related Matter records, the Matter Reference is displayed in the list beside the Matter number.

Inbox and Email

3839729 The font size and style of email signatures matches the body of the email.

Installation

3829636 Addressed an issue with an error message occasionally appearing while copying .ini files.

Invoice Form

4034927 Addressed an issue with the inclusion of expense items on invoice summaries.

Juris

4029987 Updates in Juris to unmatched fields will not cause duplicate records to be created in Time Matters.

Matter Form

4083124 Users can customize the MatterRef field to make it a non-required field.

Other

4002140 When a record is open on two workstations, warning messages about conflicting changes appear consistently.



PCLaw® Link

3696688 Addressed an issue where an unmatched Time Matters Staff is matched to the PCLaw Lawyer field after

being marked Inactive.

Setup

3820109 The Sort Order tab on the Set List Options screen has been reinstated.

SQL 2005

3599215 Addressed an issue where the installer occasionally did not detect a local SQL Server instance.

Synchronization

2931950 Single character Event classification codes are represented correctly in the Class Code field after the

Event is sent to Microsoft® Outlook® and then sent back to Time Matters.

Plans for the future

The following issues will be addressed in a future release.

Account Reconciliation

4056472 Issue with generating Account Reconciliation reports on computers running Windows 7 64-bit.

BlackBerry Sync

Issue with Billing Items displaying on the BlackBerry after being added to the Time Matters database.

Database

In the Remote Synchronization wizard, when the option is selected to back up the host database prior to synchronization, the backup process produces an error message.

Exchange Sync

When security settings prevent Exchange Synchronization from adding a new record, the record is still not included in the synchronization after security settings are changed to permit the addition of records.

Changes to field matching for Contacts, Events, and ToDo's require the user to restart the Exchange Synchronization service manually.

Forms

When two users have the same record open and make changes to the Memo field, a change reconciliation notification should be displayed.

3741314 If a host database contains a custom property file, the custom property file is not created when creating and installing a clone database file.
