Lexis Advance

Where to research next? Review your Research Map at Lexis Advance and:

View your history as a **graphic display** that makes it easy to review each step of your research, e.g., number of results in each content type; filters you applied or removed; documents viewed, delivered, *Shepardized*TM or saved to a folder.

- **Compare search results** for up to three searches to find common results—and ensure you've covered your bases.
- **Find simillar documents** Compare up to three results documents of the same kind, e.g., three cases, and retrieve related and possibly even more relevant documents to help your position.
