- Retain source **history in a rolling list** in the box. To display and choose these sources, click on the list. Sources may roll off the list unless you pin them there to keep them handy.
- Find key practice-focused legal topics by going to the **Search by Legal Topic or Headnote box**. Search or link to the LexisNexis Legal Topic hierarchy.
- Set **multiple Alerts** for the topic and each content type you follow. Alerts update periodically. The cost of Alert searches and update deliveries are generally in addition to your subscription cost.
